Bids for segregated items or portions of work will not be considered, except as stipulated. **ALL FORMS IN THE BID PACKAGE MUST BE COMPLETED, SIGNED AND DATED IN BLUE INK.** This contract will be awarded to the most responsive, responsible, bidder submitting the lowest BASE BID.

All bid documents must be sealed with the outside of the envelope clearly marked: DOCUMENTS ENCLOSED – PROJECT TITLE: “ASPHALT RESURFACING OF CITY LIMITS ROAD, BOGALUSA, LA.”; INCLUDE CONTRACTORS NAME AND LOUISIANA CONTRACTORS LICENSE NUMBER, on outside of envelope. Bid specifications may also be reviewed and proposals submitted on [www.centralbidding.com](http://www.centralbidding.com) prior to the deadline.

It is understood that the quantities shown on the bid form are approximate only and are subject to increase or decrease and that whether the quantities are increased or decreased, the work will be done at the unit prices stated in the unit pricing schedule of the bid form. If the total cost of any item or Total Base Bid is inconsistent with the unit cost, the unit cost shall prevail. If there is a discrepancy between words and figures, the words shall prevail.

It is understood and agreed that the undersigned has examined the plans and specifications and has, by inspection at the site of the work, satisfied himself as to the nature of the work to be done and has the knowledge as to the conditions and matters which can affect the work of the cost thereof and furthermore understands and agrees that the Washington Parish Government will in no way be responsible for any errors or omissions in the bid.
