H. Past performance by person or Firm on Parish contracts. Please attach additional pages if necessary.

LMB Services, LLC v. The Parish of Jefferson, 24th JDC, No. 837-222, Div. K. - Hope Haven Project. This matter was a Mandamus under La. R.S. 38:2191 for the Parish's alleged failure to pay LMB Services after a termination for convenience. The parties reached a settlement at trial.

Command Construction, LLC v. The Parish of Jefferson, 24th JDC, No.831689, Div. C. - W. Esplanade Project. As a result of litigation related to the bid for the Project, Command Construction, LLC's contract with the Parish is an absolute nullity; therefore, based on longstanding jurisprudence in Louisiana, Command is only owed for its costs and no overhead and profit. However, Command refused to provide the Parish with documentation regarding its costs for the Project and filed suit under various theories of law, including breach of contract, detrimental reliance, unjust enrichment, and open account. Currently, the matter is stayed at the District Court, while an appeal is pending with the 5th Circuit regarding the nullity of the contract and the Parish's acceptance of the Project under the Public Works Act.

The Severn Project - This is a companion to the litigation listed above. In this matter, DBE subcontractor, Twin Shores, filed suit against Command, the general contractor, and Kelly Commander, its principal, on the Severn Project under the Prompt Pay Act for its failure to pay Twin Shores for its work. This Project is partially funded by the State and because of Twin Shores' claim, the funding for the Project has been halted. At this time, the Parish is not a party, but is monitoring and taking the necessary steps with the State and Command to ensure that the funding for the Project is not jeopardized as a result of Command's actions.

Katherine Verrette v. Command, Design Engineering, Inc, and Jefferson Parish, 24th JDC, No. 818-241, Div. H - In Verrette, the Plaintiff alleged injuries resulting from Command's work. Riess LeMieux was retained as neither Command or its insurers would accept the Parish's tender of defense and indemnity. As it relates to coverage, we have filed suit against Command, its insurer, and the OCIP carrier for defense and indemnity. To date, the parties have not answered. However, we have made contact with the OCIP carrier, and it is anticipated that they will pick up the defense and issue a reservation of rights. Further, at this time, Riess LeMieux is defending the Parish on the merits of this matter.

Masooda Kahn v. Command and Jefferson Parish, 24th JDC, No. 847-962, Div. P – In Kahn, the Plaintiff has alleged that her home sustained damage as a result of Command's construction activities. This matter is in its infancy and Riess LeMieux was retained days before the submission.

However, in the spirit of full disclosure, there is currently a pending adversarial matter captioned Parish of Jefferson v. NSN Development, 24th JDC, Div. C, 824-531. This matter involves alleged damage to trees in the Parish right of way.
