1. Bids shall be submitted on the attached bid form. In order to be in compliance with the Louisiana Revised Statute 38:2212.A.(1)(c), all bids shall be either hand delivered or sent by registered or certified mail with a return receipt requested to the Morgan City Harbor and Terminal District, 800 Youngs Road, Morgan City, LA 70380, in a sealed envelope clearly marked on the outside, BID ON GENERATOR@. All bids arriving after the stated date and hour will be returned unopened to the bidder. No bid may be withdrawn for at least thirty (30) days after the scheduled time for the receipt of bids.

2. Bids shall include the expected delivery date and all applicable delivery charges to Morgan City Harbor and Terminal District, 800 Youngs Road, Morgan City, LA 70380

3. Model numbers, catalog cuts, descriptive literature, and detailed specifications shall be included as part of your bid.

4. Details concerning requirements are shown on the attached Exhibits AA@ and AB@. If bidding materials other than as specified, deviations from specifications must be stated as part of your bid.

It is the intent of the specifications to invite bids on high quality merchandise. Mentioning a brand, manufacturer, and number is done only to establish the standard of quality desired. It is not the intent to eliminate brands of equal quality but instead to set forth and convey to prospective bidders the general style, type, character and quality of the product desired.

5. Successful bidder must furnish a Certificate of Insurance prior to the start of work. The certificate should provide the following: General Liability Insurance, including Blanket Contractual and Products Liability, with Completed Operations Liability where applicable with minimum limits of \$750,000 combined single limit and \$100,000 Property Damage.

Comprehensive General Automobile Liability Insurance with minimum limits of \$100,000/\$300,000 Bodily Injury and \$50,000 Property Damage. Statutory Workmen=s Compensation with \$100,000 Employers Liability Coverage.

6. Contractor shall be responsible for all permits, agency approvals and design to meet all applicable codes. If the generator being offered is required to be skid mounted in order to comply with manufacturer's recommendations, permitting or codes, taxes must be remitted to the St. Mary Parish Tax Collector.

7. Cash discounts, if offered, will be taken into consideration in determining the low bidder. DISCOUNTS LESS THEN THIRTY (30) DAYS WILL NOT BE CONSIDERED IN MAKING AN AWARD. Beginning date for discount period shall be determined by date of invoice or date of project completion whichever occurs last.

8. The Morgan City Harbor and Terminal District reserves the right to select a higher priced item where, in the judgment of the Executive Director of the Morgan City Harbor and Terminal District, such item is of superior quality or design or would be more suitable for the purpose intended. The Morgan City Harbor and Terminal District further reserves the right to reject any and all bids, adjust quantities by increasing or decreasing, and to waive all informalities.
