The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail. Quotations shall be based on F.O.B. Delivered, anywhere within the Parish as designated by the Purchasing Department. JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR. Items bid must meet specifications. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. TWO (2) YEAR SUPPLY OF OXYGEN, ACETYLENE, ARGON AND PROPANE, REFILLING ONLY, BOTTLES FOR ALL SEWERAGE DISTRICTS OF THE DEPARTMENT OF PUBLIC WORKS AND ALL PUBLIC WORKS DEPARTMENTS

### GENERAL

Deliveries shall be made to various departments located on both the East and West Banks of Jefferson Parish, as directed on each purchase request.

Bidder is not to pre-ship any quantity until authorized by purchase order.

"Refilling" tanks shall include picking up empty tanks from various departments located on both the East and West Banks of Jefferson Parish, filling the tanks off-site, and returning the tanks.

Vendors shall be responsible to ensure that the tanks will be safe after refilling, in all aspects in that they meet minimum safety code requirements and standards acceptable to the trade.

Further, the vendor advises the respective department when tanks are not usable for refill or unsafe for said use.

### TECHNICAL SPECIFICATIONS

Vendors are requested to quote a unit price per cubic foot for refills only, on supplying all products, welding grade oxygen, acetylene, and argon, which shall be based on tank cylinders being furnished by each department's districts having the following cubic foot range capacities:

OXYGEN: 224 cu. ft. to 281 cu. ft., dependent on numbers stamped on safety valve of each tank

ACETYLENE: 200 cu. ft. to 350 cu. ft., dependent on the pressure rating of each tank

ARGON: 336 cu. ft., dependent on number stamped on safety valve of each tank

Vendor is to quote a unit cost for valve or tank replacements and for tank purification on oxygen tanks when necessary.
