Specifications for Schelde Sports Brand Infinity I4 Volleyball System

Model SSVB404P INFINITY I4 UPRIGHT WINCH AND END

Removeable type, in floor sleeves. Uprights shall be single piece, 120" long and anodized 6061-T6 aluminum, 3-15/16" outside diameter weighing 31 and 38 lbs. Net shall attach at only 2 points on both winch and end post. Model SSVB403C INFINITY I4 CENTER UPRIGHT WITH WINCH

Infinity I4 center post shall consist of single upright as described above with winch rail on one side and end rail on opposite side allowing nets to be set up on adjacent courts. Posts weight 39 lbs. Uprights shall be capable of net heights from 8'-2" to 42" to accommodate all net sports. Upright and winch shall carry no less than limited lifetime warranty.




