## **Brief Overview of Nominated Project**

### **Project Description**

This project includes the cleaning and painting of all metal surfaces on two bridges on US101 @ M.P. 194.3 and 212.5. These are overhead steel truss bridges that were in need of repainting. The project also included new paved panel joints and new expansion joints on the driving surface of the bridges.

### **Customer-Focused Administration**

During the course of the project, it was evident that Southern Road and Bridge wished to perform the highest quality work within the least amount of time. They also partnered with WSDOT on more than one occasion to mitigate the impacts to the traveling public by opening up both lanes when construction activities were not ongoing. This was greatly appreciated by the surrounding community during a weekend festival in Forks, WA. Southern Road and Bridge was receptive and very quick to respond to any requests by WSDOT.

### **Innovative Problem Solving**

Southern Road and Bridge proposed a cost reduction to the project to utilize recyclable abrasive blast media to remove the existing paint, rust, and other foreign material on the steel bridges. By utilizing recyclable abrasive blast media they were able to complete the blasting with significantly less abrasive material and generated significantly less hazardous waste. The storage and disposal of hazardous waste is a force account item paid by WSDOT, and this innovative solution greatly reduced this cost to the taxpayers. Southern Road and Bridge brought up very specialized equipment to recapture, separate, and reuse the steel grit during the blasting process. It was very evident that Southern Road and Bridge was a highly experienced company whose mission was to perform very high quality work with as little impact to the environment as possible.

### **Overcoming Extraordinary Challenge**

There were several challenges that were overcome on this project:

1. Class 1 containment was required. This is the highest level of containment and Southern Road and Bridge was able to meet the specifications with no major releases.
2. Short project duration with limited working hours. This project was to be complete in 90 working days with only Sundays not being counted. Due to nesting birds in the area, the Contractor was only allowed to work between 2 hours after sunrise to 2 hours prior to sunset. To meet this aggressive schedule, Southern Road and Bridge worked numerous Sunday shifts and in the end worked

on both bridges simultaneously to complete the project within the allowable working days.

3. First WSDOT contract by an out of state company. This was Southern Road and Bridge's first WSDOT contract and they worked diligently to learn our submittal and materials acceptance processes. To add to this challenge, WSDOT bridge and structure reviews were hired out to a consultant. This meant that the lines of communication went through 1 extra channel and this added time and confusion to the process of approving submittals. Southern Road and Bridge worked diligently to return corrections asap and was able to get all submittals approved without significant delays to the project. Even during the most frustrating times, the project team from Southern Road and Bridge kept a positive attitude, responded quickly, and remained professional.
4. Weight/ Loading restrictions on the bridges. Due to weight/load restrictions, the bridges had to be painted in stages. First, the underdeck steel was painted with the requirement that only 1 lane of traffic could be allowed and had to be in the center of the bridge. Then once the underdeck platform and containment was removed, then the traffic could be swapped to one side or another to perform all the overhead work. This restriction made the task of completing the project in a short duration that much more difficult.

#### Effective Contract Administration

Southern Road and Bridge did a fantastic job of learning a new process and submitting all documentation prior to beginning work. The project teams communicated very well and kept a very professional attitude. Submittals and materials documentation was submitted in a timely manner and all requests from WSDOT were answered quickly. Southern Road and Bridge was also very helpful and took the time to explain any items of confusion to the WSDOT team.

#### Timely Completion of Project

Southern Road and Bridge worked very efficiently and was able to complete both bridges within the allowable time. They worked numerous Sundays to make this happen and they were determined to get the work done in time.

#### Safety

Southern Road and Bridge is a safe working company and there were no accidents on this project. They were also very helpful with ensuring that our project inspector had appropriate equipment and stayed safe at all times. They went above and beyond what was required to drive our inspector from the project site back to the shower facility each day during the blasting and painting work. In addition, when our inspector was ill, the project foreman volunteered to driver her to the local hospital. This was appreciated greatly and showed that Southern Road and Bridge cared about all members of the project team.

**NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Nature of Operations:*

The Company operates as a contractor engaged in paving roadways and restoring bridges, generally across the Southeast. The work is performed primarily under unit-price and fixed-price contracts. Contract lengths vary but are typically less than one year.

*Accounting Estimates:*

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates. Management periodically evaluates estimates used in the preparation of the financial statements for continued reasonableness. Appropriate adjustments, if any, to the estimates used are made prospectively based upon such periodic evaluation. It is reasonably possible that changes may occur in the near term that would affect management's estimates with respect to the percentage of contract completion, allowance for doubtful accounts, useful lives of property and equipment, and overhead cost allocations.

Revisions in estimated contract profits are made in the year in which circumstances requiring the revision become known.

*Balance Sheet Classifications:*

The Company includes in current assets and liabilities retentions receivable and payable under construction contracts that may extend beyond one year. A one-year time period is used as classifying all other current assets and liabilities.

*Marketable Securities:*

Marketable securities consist of equity and exchange-traded securities that are reported at fair value. Unrealized holding gains and losses on equity securities are included as a component of net investment income. Realized gains and losses on the sale of equity securities are determined using the specific-identification method, and are included as a component of net investment income (loss).

*Revenue and Cost Recognition:*

The construction services performed under each contract represent a single performance obligation that is satisfied over time. Revenues from construction contracts are recognized over time using the cost-to-cost input method, measured by the percentage of costs incurred to date to estimated total costs for each contract. This method is used because management considers costs incurred to date to be the best available measure of progress on these contracts. Because of the inherent uncertainties in estimating costs, it is at least reasonably possible that the Company's estimates of costs and revenues will change in the near term.

Contract costs include all subcontract, direct material and labor costs and those indirect costs related to contract performance, such as indirect labor, insurance, supplies, tools, repairs and depreciation. Costs of inefficiencies or wasted resources (material or labor) are excluded when measuring progress and are expensed as incurred. General and administrative costs are charged to expense as incurred. Provisions for estimated losses on uncompleted contracts are made in the period in which such losses are determined. Changes in job performance, job conditions and estimated profitability, including those arising from contract penalty provisions and final contract settlements, may result in revisions to costs and income and are recognized in the period in which the revisions are determined. Changes in estimated job profitability resulting from variable consideration (such as incentives for completing a contract early or on time, penalties for not completing a contract on time, claims for which the Company has enforceable rights, or contract modifications/change orders in which the scope of modification has been approved, but the price has not been determined or approved) are accounted for as changes in estimates in the current period, but limited to an amount that will not result in a significant reversal of revenue in future periods.

*Contract Receivables:*

Contract receivables from construction are based on amounts billed to customers. The Company provides an allowance for doubtful collections, when necessary, which is based upon a review of outstanding receivables, historical collection information, and existing economic conditions. Normal contract receivables are due 30 days after issuance of the invoice. Retainages are due upon completion of contracts. Unbilled receivables result from accrual of revenues on contracts completed for which billings have not yet been rendered. Retainage and unbilled receivables for which the right to payment is unconditional are included in contract receivables. Contract receivables past due more than 30 days are considered delinquent. Delinquent contract receivables are written off based on individual credit evaluation and specific circumstances of the customer. Balances that remain outstanding after the Company has used reasonable collection efforts are written off. Management determined no allowance was necessary as of December 31, 2022.

*Contract Assets and Contract Liabilities*

The contract asset, “Costs and estimated earnings in excess of billings on uncompleted contracts,” represents revenues recognized in excess of amounts billed. The contract liability, “Billings in excess of costs and estimated earnings on uncompleted contracts,” represents billings in excess of revenues recognized.

Retainage on uncompleted contracts and unbilled receivables that are not due until certain contract conditions are met, and accrued losses on uncompleted contracts, are included in contract assets and contract liabilities. The Company’s contract assets and contract liabilities are reported net, on a contract-by-contract basis.

*Property and Equipment:*

Property and equipment are stated cost and depreciated over the estimated useful lives of the individual assets utilizing the straight-line method. Estimated useful lives are generally as follows:

Office furniture and equipment	5 - 7 years
Construction equipment	5 - 10 years
Transportation equipment	5 years

Major expenditures for property and equipment, and those which substantially increase useful lives, are capitalized. Maintenance, repairs and minor renewals not included as contract costs are expensed as incurred. When assets are retired, or otherwise disposed of, their costs and related accumulated depreciation are removed from the accounts and any resulting gain or loss is included in income for the year.

*Income Taxes:*

The Company, with the consent of its members, has elected to be taxed as a partnership under the provisions of the Internal Revenue Code, whereby income is passed through to the individual members. Under this election, the Company does not pay any federal or state income taxes. Accordingly, no provision for income taxes on current period income has been made in the accompanying financial statements.

If it is probable that an uncertain tax position will result in a material liability and the amount of the liability can be estimated, then the estimated liability is accrued. If the Company were to incur any income tax liability in the future, interest on any income tax liability would be reported as interest expense, and penalties on any income tax would be reported as income taxes. As of December 31, 2022, management believes there were no uncertain tax positions.

*Leases:*

ASC 842, “Leases” (“ASC 842”) requires a lessee to recognize a right-of-use asset and a lease liability for all leases with a term greater than 12 months on its balance sheet regardless of whether the lease is classified as financing or operating.

*Leases (Continued):*

The Company's lessee arrangements include operating leases for various pieces of equipment. Under these arrangements, the Company records right-of-use assets and corresponding lease liabilities, each of which is based on the present value of the remaining lease payments discounted using the risk-free rate practical expedient allowable under ASC 842. Right-of-use assets are reported in noncurrent assets and the related lease liabilities are reported in current and long-term liabilities on the balance sheet. All leases are recorded on the balance sheet except for leases with an initial term less than 12 months for which the Company elected short-term lease recognition under ASC 842. Lease terms may contain renewal and extension options and early termination features. Lease expense is recognized on a straight-line basis over the lease term.

*Recent Accounting Pronouncements:*

In February 2016, the Financial Accounting Standards Board ("FASB") issued Accounting Standards Update ("ASU") 2016-02 - *Leases (Topic 842)*. The guidance in this topic supersedes the requirements in ASC Topic 840, *Leases* ("ASC 840"). With the exception of short-term leases, the updated guidance requires lessees to recognize a lease liability representing the lessee's obligation to make lease payments arising from a lease, measured on a discounted basis, and a right-of-use asset representing the lessee's right to use, or control the use of, a specified asset for the lease term upon adoption. Lessor accounting was largely unchanged under the new guidance, except for clarification of the definition of initial direct costs which provided additional guidance on the timing of recognition of those costs. Subsequent to the issuance of this update, the FASB issued three additional ASUs that provide codification improvements and certain transition elections. The Company adopted the standard effective January 1, 2022, using the modified retrospective transition method permitted by ASU 2018-11. The Company has included newly applicable lease disclosures in Note 10.

In March 2020, the FASB issued Accounting Standards Update No. 2020-04 ("ASU 202-04"), *Reference Rate Reform* (Topic 848): Facilitation of the Effects of Reference Rate Reform on Financial Reporting. ASU 2020-04 provides optional expedients and exceptions for applying GAAP to contracts, hedging relationships, and other transactions effected by reference rate reform. The amendments in this standard can be applied any time before the fourth quarter of 2023. The Company is currently in the process of evaluating the impact of the adoption of the new rules on the Company's financial condition, results of operations, cash flows, and disclosures.

*Subsequent Events:*

Management has evaluated subsequent events through March 10, 2023 which is the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

FASB Accounting Standards Codification 820 (“ASC 820”), Fair Value Measurements, defines fair value, establishes framework for measuring fair value, and requires disclosure about fair value measurements. The guidelines establish a fair value hierarchy about the assumptions used to measure fair value and clarifies assumptions about risk and the effect of a restriction on the sale or use of an asset.

ASC 820 defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC 820 also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

Three levels of inputs may be used to measure fair value:

Level 1: Observable inputs such as quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, and other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect a company’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

**NOTE 11 - COMMITMENTS AND CONTINGENCIES**

*Concentration of Credit Risk:*

The Company's cash balances held at financial institutions are insured by the Federal Deposit Insurance Corporation ("FDIC") up to certain limits. At December 31, 2022, the Company had cash balances of \$981,275 held by financial institutions in excess of insured limits.

*Concentration of Revenue - Major Customers:*

The Company's customer base consists of a diverse mix of corporate and governmental entities in a wide variety of industries. During 2022, the Company derived 53% of its total contract revenue from three major customers. Amounts due from these three major customers comprised 65% of total contract receivables and retainage at December 31, 2022.

*Legal Matters:*

The Company is a party to litigation in the normal course of operations. Management does not believe that the impact of any outstanding legal matters will have a material adverse impact on the Company's results of operations or financial position.

**NOTE 12 - RELATED PARTY TRANSACTIONS**

The Company leases a facility under a month to month agreement that expires at the end of 2023 with an entity related by common ownership. Lease expense for the year ended December 31, 2022 was \$56,006.

**NOTE 13 - PRIOR PERIOD ADJUSTMENT**

Members' equity as of January 1, 2022 has been adjusted to correct errors made in the prior year for the overstatement of contract revenues and the understatement of contract liabilities from completed contracts. The effect of the prior period adjustment was to decrease members' equity and net income and increase contract liabilities as of and for the year ended December 31, 2021 by \$615,181.
