

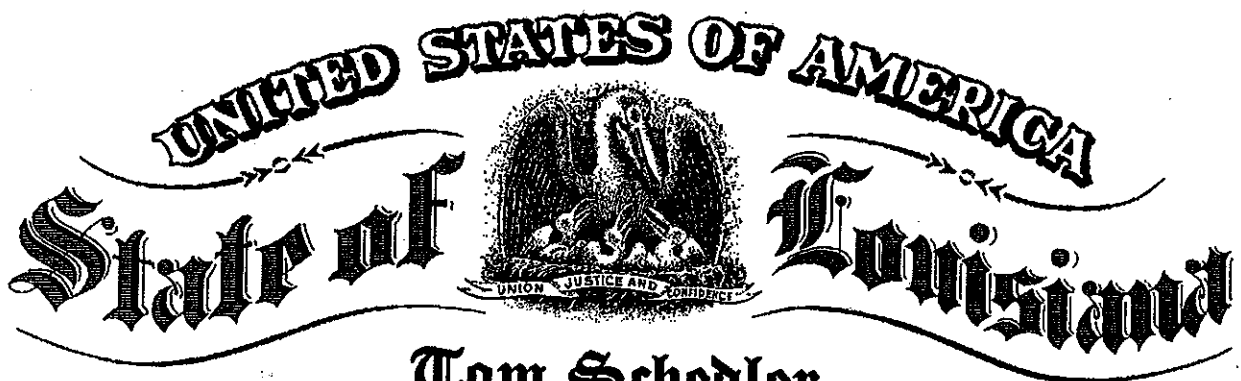

Powers of the Manager


