Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law. Unless otherwise specified, all workmanship and materials must have at least one (1) year guaranty, in writing, from the date of delivery and/or acceptance of the project. Any deviations or alterations from the specifications must be indicated and/or supporting documentation supplied with bid submission.

Every contract or order shall be awarded to the LOWEST RESPONSIVE and RESPONSIBLE BIDDER, taking into consideration the CONFORMITY WITH THE SPECIFICATIONS and the DELIVERY AND/OR COMPLETION DATE. SPLIT AWARDS MADE TO SEVERAL VENDORS WILL ONLY BE GRANTED TO THOSE DEEMED RESPONSIVE AND RESPONSIBLE.

All bid prices shall remain valid for 45 days. Jefferson Parish and the lowest responsive and responsible bidder(s) by mutual written consent may mutually agree to extend the deadline for award by one (1) or more extensions of thirty (30) calendar days.

PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. Written protest must be received within 48 hours of the release of the bid tabulation by the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. (For more information, please see Chapter 2, Article VII, Division 2, Sec. 2-914.1 of the Jefferson Parish Code of Ordinances.)

PREFERENCE: Unless federal funding is directly spent by Jefferson Parish for this purchase, preference is hereby given to materials, supplies, and provisions produced, manufactured or grown in Louisiana, quality being equal to articles offered by competitors outside the state. "LSA - R.S. 38:2251-2261"

B. USE OF BRAND NAMES AND STOCK NUMBERS: Where brand names and stock numbers are specified, it is for the purpose of establishing certain minimum standards of quality. Bids may be submitted for products of equal quality, provided brand names and stock numbers are specified. Complete product data may be required prior to award.

C. CANCELLATION OF CONTRACT: JEFFERSON PARISH reserves the right to cancel all or any part if not shipped promptly. No charges will be allowed for parking or cartage unless specified in quotation. The order must not be filled at a higher price than quoted. JEFFERSON PARISH reserves the right to cancel any contract at anytime and for any reason by issuing a THIRTY (30) day written notice to the contractor.

For good cause and as consideration for executing a contract with Jefferson Parish, vendor conveys, sells, assigns and transfers to Jefferson Parish or its assigns all rights, title and interest in and to all causes of action it may now or hereafter acquire under the antitrust laws of the United States and the State of Louisiana, relating to the particular good or services purchased or acquired by Jefferson Parish.

D. PRICES: Jefferson Parish is exempt from paying sales tax under LSA-R.S. 47:301 (8)(c). All prices for purchases by Jefferson Parish of supplies and materials shall be quoted in the unit of measure specified and unless otherwise specified, shall be exclusive of state and local taxes. The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail.

Quantities listed are for bidding purposes only. Actual requirements may be more or less than quantities listed.

Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. Furthermore, failure to attend the pre-bid conference and inspection does not relieve the successful bidder from the necessity of furnishing materials or performing any work that may be required to complete the work in accordance with the specification with no additional cost to the owner.
3. Contractor must hold current applicable JEFFERSON PARISH licenses with the Department Building Permits. Contractor shall obtain any and all permits required by the JEFFERSON PARISH Department of Building Permits. The contractor shall be responsible for the payment of these permits. All permits must be obtained prior to the start of the project. Contractor must also hold any and all applicable municipality, Federal and State licenses. 5. It is the bidder's responsibility to visit the job site and evaluate the job before submitting a bid.
6. Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Flammable material must be removed from the job site daily because storage will not be permitted on the premises. SCOPE OF WORK

The Jefferson Parish Department of Public Works – Parkways Department (Parkways) is soliciting qualified Contractors for a two (2) year as-needed contract to supply materials and labor for turnkey hydroseeding throughout Jefferson Parish. The scope of work shall include all quantities and procedures required within these specifications. All pricing shall include the necessary equipment, incidentals, licenses, insurance, labor, fuel and transportation to perform the work. The Contractor shall refer to Resolution No. 136353, as amended, which provides a uniform set of "General Conditions and Agreement for all contractors engaged in performing work or services for the Parish of Jefferson".

SITE LOCATIONS

This as-needed contract shall cover all rights-of-way, canals and parish property located throughout unincorporated Jefferson Parish. When hydroseeding is requested, the Contractor shall be provided an exact address, and/or a map of the site location for reference. Acreage quantities will be verified by field measurements and/or satellite mapping.

LICENSING

Bidders shall possess the following licenses:

- Louisiana State Contractors' Commercial license with the sub-classification of: LANDSCAPE, GRADING AND BEAUTIFICATION

- Louisiana State Contractors' Commercial license with the classification of SPECIALTY: LIMITED SPECIALTY SERVICES

Mix #3 - Fall/Winter Mix – Less Than 3:1 Slope

- 100 lbs of certified unhulled Bermudagrass seed per acre
- 75 lbs of certified annual ryegrass seed
- 100 lbs of 19-19-19 starter fertilizer per acre
- 2,500 lbs of cellulose mulch with tackifier per acre (Profile® Cellulose with Tackifier, or approved equal).

Mix #4 - Fall/Winter Mix – Greater Than 3:1 Slope

- 100 lbs of certified unhulled Bermudagrass seed per acre;
- 75 lbs of certified annual ryegrass seed;
- 100 lbs of 19-19-19 starter fertilizer per acre;
- 3,000 lbs of wood fiber mulch/erosion control per acre (Flexterra® HP-FGM, or approved equal).

Note: Tackifier shall be included with the mulch from the manufacturer. Tackifier shall not be a separate additive to the hydroseeding mixture.

The Contractor shall be required to submit information to Jefferson Parish on all products to be used before each hydroseeding application. Failure to submit, and receive approval of, products may result in non-payment for the work.

For each requested hydroseeding application, all seed, fertilizer and mulch shall arrive to the application site, or a predetermined mobilization site, in unopened manufacturer's packaging and be available for inspection by Jefferson Parish prior to application.

If advanced noticed is provided to Jefferson Parish, the Contractor may utilize a water source located at either of the two Parkways Department's maintenance yards: 200 Shrewsbury Road, Jefferson, LA 70121 or 1855 Ames Boulevard, Building A, Marrero, LA 70072. The Contractor shall be responsible for securing any other water source(s) for hydroseeding applications.

This contract shall be for hydroseeding only and shall not require the Contractor to fill, grade, clean or apply any chemicals to a site prior to hydroseeding. However, the Contractor will be responsible to repair and grade any damage to the site caused by his equipment during his hydroseeding operations.

Upon completion of each hydroseeding application, the Contractor shall be responsible for cleaning the curbing, street, sidewalk, trees, drain pipes, signs, benches or any other structure where overspray may take place.

The Contractor shall determine the equipment to be used for each application, but shall utilize a hydroseeding machine with a minimum tank size of 400 gallons with continuous agitation.

PAYMENT

Each hydroseeding mixture (see HYDROSEEDING SPECIFICATIONS) shall be priced based on the requested area of the site. For sites less than 1 acre in size, the Contractor shall provide a price per square foot. For sites larger than one acre, the Contractor shall provide a price per acre.
