This request is to provide the Jefferson Parish Library Department with a two-year film streaming online database subscription to compliment current library resources for all library locations.

Purpose: To provide a streaming film service that is informational, educational, and entertaining movies and documentaries suitable for a wide range of library patrons. Content must complement current library resources. The service must be easy to use and compatible with most devices and computers. Children mode must be available. This service must include all vendors' content with a pay per use pricing model and public performance rights for all content.

An online streaming film service subscription for a public library must include the following:

URL to vendor's online service that can be placed on the library's website and the entire service and its content must be available virtually online, on a server hosted by the vendor.

Users can stream movies anywhere, any time, on most devices and computers with internet access.

Provide at least 30,000 movies and documentaries from at least 1,000 producers. Producers must include Criterion Collection, Great Courses, PBS, Kino Lorber, and Media Education Foundation.

Content must include award winning films, independently produced, foreign language, and lesser-known films, not widely available via other resources.

Content is rated PG-13 and lower. Users can set their accounts to children's mode.

Users can create watch-later lists, play lists of clips, share clips with other library card holders.

All content must include public performance rights for showing to a group at the library.

The service must include all vendor's content with a pay per use pricing model.

No upfront deposit is required.

The library must be able to set user check-out limits per month and total library use per month.

Administrator website to set user limits, view usage details, and budget usage.

Please note that in regard to the page marked SP-1 in the RFP documentation for Bid Number 50-00147018, Kanopy requests the following amendments to the requirements:

- In the last sentence of the second paragraph, please delete the following phrase: “and public performance rights for all content.”
 - Explanation: While Kanopy does offer Public Performance rights to a large percentage of the Titles made available on our Platform, the reason for the above requested deletion is that Kanopy has not been granted Public Performance rights for *all* of the Titles on our platform. This is due to the fact that not all of Kanopy’s content partners have agreed to grant Kanopy such rights, and in many occasions, they are unable to grant Kanopy the requested rights due to contractual obligations with third parties.
- Please remove the following sentence: “Content is rated PG-13 or lower.”
 - Explanation: Not all of the content found on the Kanopy platform is rated PG-13 or lower. There are a number of R rated and unrated films. Furthermore, Kanopy does not have the platform functionality to filter your library’s available collection based upon rating. Although, and for the avoidance of doubt, Kanopy is able to support the removal of individual Titles from the Jefferson Parrish library’s collection, upon receipt of such a request from the library.
- Please remove the following sentence: “All content must include public performance rights for showing to a group at the library.”
