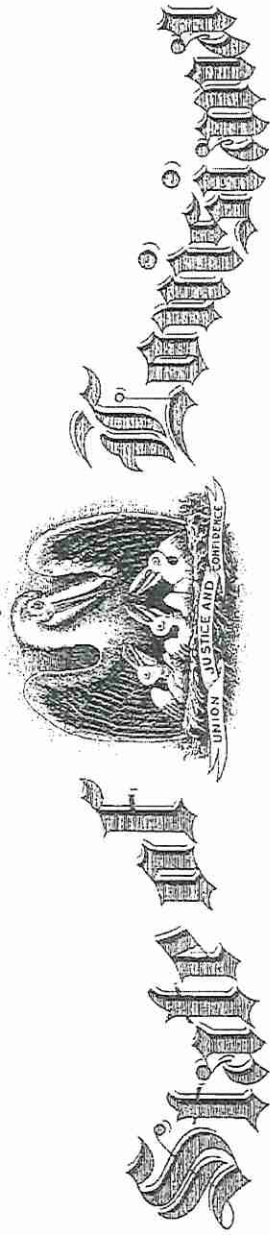

Section 1.0 – Site Visit:

Section 2.0 – Scope:

We extend this proposal to provide all labor, materials, delivery, equipment, and all other incidentals needed to replace One (1) existing Wessels Company air-separator tank in the Jefferson Parish Central Plant located at 960 1st Street, Gretna, LA.

Section 3.0 – License:

A Louisiana State Contractor's License will be required in accordance with LSA R.S. 37-2150 et. seq., and such license number will be shown on the outside of the electronic bid envelope. Failure to comply will cause the bid to be rejected. When submitting the bid electronically, the license number must be entered in the appropriate field in the electronic procurement system. Failure to comply will cause the bid to be rejected." A copy of the license is not required by law;

Section 4.0 – Quantities/Inspections:

Bidders must inspect the site and perform their measurements to determine the proper quantity of materials and equipment required to complete this project. All measurements given in these specifications are for informational purposes only.

Section 5.0 - Submittals:

If the bidder intends to provide materials equal to or better than owner-specified materials, the following shall be provided with their bid:

Section 6.0 – Specifications:

- Design, engineer, supply, and install one (1) new air-separator tank to match or exceed the existing chill-water air-separator tank.
- All equipment and materials shall be bidder-supplied new.
- Bidder shall coordinate all clearances concerning structural limitations. No additional compensation will be allowed for this work.
- Any modification or changes needed to the existing air-separator tank supports or chill-water piping shall be included in this bid and match existing material.
- Before any work begins, an owner's representative and the successful bidder shall inspect, document, and take photos of all existing building conditions.

Section 6.1 Demolition:

- Remove and properly dispose of one (1) existing air-separator tank and all associated piping necessary to install one new tank.

Section 6.2 Insulation:

- Remove and dispose of all insulation associated with the air separator and chilled water piping in the chiller room
- Insulate the air separator and chilled water piping in the chiller room that was affected by the installation of the new air separator.
- Rubber insulation shall be a minimum of 1 inch thick on air-separator and chill-water flanges
- Rubber insulation shall be painted to match the existing color.
- Fiberglass insulation shall be at least 2 inches thick on chill water lines.
- Install color-matching PVC jacketing on all piping and fittings in the chiller room.
- PVC Jacketing shall be a minimum of 15 mills thick.

Section 7.0 - Hours of Work:

The work to be performed shall be scheduled after normal working hours, Friday after 5:00 p.m. to 7:00 a.m. Monday. All work shall be scheduled seventy-two (72) hours in advance. The successful bidder may choose to work before or after regular building working hours to provide a safe work environment at no extra charge to Jefferson Parish.

Section 8.0 – Warranty:

All artistry and materials shall have a minimum of one (1) year of parts and labor warranty in writing from the manufacturer starting from the date of acceptance of the project against defects. The bidder must agree, upon written notice from the owner, promptly and without charge, and to the satisfaction of the owner, to make changes, replacements, and corrections that may be required to cause good all defects in materials and equipment under its intended use, within the warranty period, at no cost to the owner.

Section 9.0 – Permits:

The successful bidder shall obtain any permits required by the Jefferson Parish Department of Inspection and Code Enforcement. The successful bidder shall also be responsible for the payment of these permits. All permits must be obtained before the start of the project.

Section 10.0 – Liquidated Damages:

Commencing on the thirty-first day following the notice to proceed until work is substantially complete, liquidated damages will be assessed for \$100/day.
