If the Bidder fails to complete all requirements for executing the "Contract Between Owner and Vendor and Performance and Payment Bond" within ten (10) days after notification, the Owner may reject the Bid, retain the Bid Bond, call in the surety for payment, and award the contract to the next lowest bidder.

REJECTION OF BIDS:

The Bidder understands that the Owner reserves the right to reject any or all bids for just cause. In accordance with La. R.S.38:2212 (A)(1)(b), the provisions and requirements of this Section, those stated in the advertisement for bids, and those required on the bid form shall not be considered as informalities and shall not be waived by any public entity.

WITHDRAWAL OF BIDS:

The Bidder agrees that this bid shall be good and may not be withdrawn for a period of thirty (30) calendar days after the scheduled closing time for receiving bids except in accordance with the provisions of R.S. 38:2214.
