F. Professional Training and experience in relation to the type of work required for the outside legal services.

Approximately five years ago, I had the distinct honor of being appointed by the Jefferson Parish Council to be a part of the Parish's legal team in representing the Parish (and ultimately the two hospital service districts within the Parish as well) for each entity's claims for damages arising from the horrific opioid epidemic that has taken our Parish, state and country by storm. Throughout the course of this representation, our team has worked vigorously in moving this case forward, including, but not limited to filing suit in federal court in the Eastern District of Louisiana, finding and working closely with a forensic accounting expert on identifying and quantifying prospective damages (whom I personally found for our team), our drafting and submission of the Parish and Hospitals' Government Fact Sheets, other federal court pleadings (within both the MDL proceeding as well as within various defendant bankruptcy proceedings) and other countless efforts during this very active and vigorous representation of the Parish's interests. As referenced above, since our initial filing of the lawsuit, this case has since been transferred to federal court in Cleveland, Ohio, and is now a part of the complex Multi-District Litigation ("MDL") that arose from similar "opioid" lawsuits from around the country – In Re: National Prescription Opiate Litigation, MDL-2804, before the Honorable Dan A. Polster for the United States District Court Northern District of Ohio, Eastern Division. From my past experiences working in the trenches of another MDL (see below), I have the good fortune of having several colleagues from around the country who also have clients within this Multi-District Litigation – which has also been a very helpful tool in coordinating on common issues faced by other governmental entities from around this country. As of the date of this updated submission, my and our team's vigorous efforts on behalf of Jefferson Parish are continuous and ongoing, and I look forward to continuing my most diligent efforts on behalf of the Parish on these matters. Additionally, as of the date of this submission, we have reached a settlement with respect to some of the underlying defendants in this complex matter, and we remain in the process of (1) finalizing logistics on these particular settlements and (2) continuing onward in the litigation with respect to the other non-settling defendants, as well as those defendants currently in bankruptcy. Also, as of the date of this updated submission, particularly over the past three years, I have been, and continue to be, one of the most active attorneys statewide with respect to coordinating efforts on behalf of all Louisiana Parishes regarding negotiations that require a unified front of all Louisiana parishes and other local governments. I am frequently called by other "opioid" attorneys statewide and am asked to provide guidance to them as they navigate their own particular clients' claims forward. I intend on continuing in this leadership capacity as things continue to progress, and I am honored and humbled to be able to do so. Over the course of the last several months, initial settlement funds stemming from our team's vigorous efforts have become available to the Parish, with additional funds forthcoming as this matter and this complex settlement process continues and as additional defendants continue to settle their cases.

As stated in my previous submissions to you, I have been admitted to practice law in the State of Louisiana since 2008, and have extensive litigation experience in both state and federal courts throughout Louisiana as well as throughout other parts of the country. Upon graduation from Loyola Law School in 2008, I served as a federal judicial law clerk to the Honorable James J. Brady of the United States District Court for the Middle District of Louisiana in Baton Rouge. Since the completion of my federal judicial clerkship, I have practiced law throughout Louisiana based out of my offices in downtown New Orleans (including my current office), and have handled numerous types of civil cases in and around Jefferson Parish and beyond. My extensive experience includes all aspects of litigation (including but not limited to trial and pre-trial work, depositions, discovery, motion practice, mediation, etc.) and other work in a variety of legal fields, including but not limited to personal injury litigation, maritime law, business litigation, environmental litigation and mass torts. While an attorney at the Williams Law Group, LLC, I worked with the Deposition and Trial Teams of the Plaintiff's Steering Committee within MDL-2179 in the United States District Court for the Eastern District of Louisiana, the massive multi-district litigation arising out of the explosion of the M/V Deepwater Horizon and subsequent BP oil spill. While this litigation spanned the course of a few years, I successfully balanced this workload with a full docket of other "more traditional" legal matters as well, including but not limited to personal injury litigation and business disputes. Over the past several years, I have also had the privilege of representing the Jefferson Parish Clerk of Court's Office on a number of occasions and have been appointed by judges of the 24th Judicial District Court for the Parish of Jefferson on numerous occasions to serve as "curator ad hoc" in an effort to assist the Court in fair and equitable resolutions to often times complex legal issues concerning residents of Jefferson Parish.

I am a regular guest lecturer every summer for the Louisiana State Bar Association at its annual convention in Destin, FL as well as a regular panelist for the LSBA's Admiralty Symposium held every year in New Orleans in the Fall. In addition to my work with the LSBA (where I also served as the Chair of the Association's Community Action Committee an am a current member of its Budget Committee, Nominating Committee and Board of Governors), I have also been asked to lecture, speak and/or moderate legal panels from a host of different organizations, including the Louisiana Association for Justice (where I serve on the Board of Governors), the Federal Bar Association (where I serve on the Board of Directors), Loyola University School of Law and Tulane University Law School, on varying topics, including but not limited to Federal Practice and Procedure, Professionalism, Maritime Law, Oral Arguments and Environmental Toxic Torts. I have presented CLEs on Legal Ethics and Professionalism to the attorneys of the Jefferson Parish Attorney's Office. I have also taught or have been asked to teach Trial Advocacy at LSU Law Center and have been selected from among my peers as a "Louisiana Super Lawyer" for the past several years.

In addition, in light of the above and also based on my past and current work experience handling complex cases for Jefferson Parish as well as private clients, I would also be honored if given the opportunity by the Parish to be appointed to any legal team representing the Parish against Defendants 3M, Dupont or any other potential Defendants in the PFAS Public Water Provider Settlements and Litigation. This is a new case of national significance whereby Jefferson Parish likely has a claim to recover damages sustained through its Water System by "Forever Chemicals" which may have entered the Parish's water supply over the years causing personal and environmental harm to our Parish and its residents.

G. Size of Firm and capacity for timely completion of newly assigned work considering the number of professional and support personnel required to perform the type of outside legal services tasks and the Firm's current unfinished workload.

A little over a year ago, my law firm, The Lambert Firm, PLC recently changed names to "Lambert Zainey Smith & Soso" and consists of five full-time attorneys, including myself, all of whom are exceptionally capable, conscientious, hard-working and skillful legal practitioners. To complement our team of attorneys, our firm has five non-lawyer staff members who readily assist our team of attorneys in our daily practices. I, along with my entire firm, remain well-equipped to handle any and all legal service tasks as they come up for Jefferson Parish in a timely manner as well as maintaining our firm's ongoing daily workload. Additionally, I, along with my entire firm, continue to maintain a regular litigation practice within the 24th Judicial District Court and beyond. While I, along with other members of my firm, have extensive experience in Multi-District-Litigation for cases of national significance going on around the country, I am uniquely equipped and capable of handling even the most complex of legal matters.

Previously Ms. Hufft, then Ms. Barton, and now Ms. Hurley, have overseen the work of our appointed "opioid" team, and I am confident would serve as a reference to the hard work and dedication I have put forth in the handling of these serious matters, as well as a reference for my experience in handling these types of complex cases. 


