Kennedy's Child Care Academy currently provides full day, full year educational services. Our scheduled closure dates include:

Kennedy's Child Care Academy currently participates in Self-Assessment interviewing processes with the Early HeadStart Program Partnership with Clover, formerly Kingsley House, and we will participate in Community Assessments.

Kennedy's Child Care Academy currently utilizes the Creative Curriculum for children ages 36 months to 60 months and Frog Street Curriculum for infants and toddlers. We also use Teaching Strategies Gold assessments and ongoing progress guidelines.

Kennedy's Child Care Academy welcomes the opportunity to participate and collaborate with JeffCap Head Start Birth-to-Five Professional Development Program and trainings. The staff currently participate in training conferences locally and attend National conferences annually. With our partnership with Clover, Kennedy's Child Care Academy participates in monthly training opportunities based on the Head Start Performance Standards, Head Start Act and Louisiana Department of Education.

Kennedy's Child Care Academy welcomes the opportunity to collaborate with JeffCap Head Start Birth-to-Five Program to expand, develop, and implement Head Start guidelines.

Kennedy's Child Care Academy has always participated in the measure of high quality. KCCA acquired a 4-star rating with the Quality Start Child Care Rating System of Louisiana.

Kennedy's Child Care Academy currently participates in the Transition Policies and Health Screening Processes with our EHS partnership with Clover that includes vision, hearing and behavior. We will conduct Screenings within 45 days of entry into the program.

Kennedy's Child Care Academy currently uses Ages & Stages for our developmental screenings and ongoing assessments for all are children enrolled for the planning of appropriate activities with individual lesson planning using Teaching Strategies Gold online system for weekly lesson planning. Our teachers currently participate in home visits before children enter the classroom as scheduled by Clover EHS partnership and we will participate in JeffCap Head Start B-5 home visits as scheduled. Our Staff Members currently conduct parent conferences and provide our parents/guardians with the information they need related to their child's progress and Outcomes will be implemented.

Kennedy's Child Care Academy will participate in all JeffCap Head Start Birth-to-Five program of activities to include, but not limited to Open House, Parent Orientation, School Readiness Fairs, Grandparent's Day, Heath Fairs, and more.

Kennedy's Child Care Academy currently maintains class sizes conducive to the age of our children in our EHS partnership with Clover in compliance with Early Head Start Performance Standards. Our current classroom sizes are 4:1 ratio for children Birth to 3 years old with a maximum classroom size of 8 children with 2 staff members. Children over the age of 3 years old will have a classroom size of 12 children to 2 staff members based on the mandated square footage of the classroom requirements. KCCA currently have a substitute teacher to ensure that all classrooms always maintain 2 staff members.

Kennedy's Child Care Academy will be in full compliance with the Head Start Performance Standards within 90 days of the contract date. In addition to completing all the necessary reports and recommendations that may be indicated for the Center to adhere to base upon any observations and findings.

Kennedy's Child Care Academy will continue to house records in accordance with LDOE, Early Head Start, and JeffCap guidelines and recommendations and maintain complete records of all services rendered under the terms of this agreement and made available upon request.

Executive Summary

Kennedy's Child Care Academy provides superior quality child care service and comprehensive educational programs for children age birth to preschool. KCCA offers drop-in services, and summer camp is available for children up to twelve years old. Parent satisfaction is very important as we have the pleasure of caring for their most valued possession-their children. Parent's participation is very important and upon admission, parents are encouraged to visit and participate in the activities of the Center. KCCA handbook has program policies for parent's responsibilities and program policies for the parents/guardians on what the program provides.

Kennedy's Child Care Academy is conveniently located in Gretna close to the Algiers/Gretna Parish line. This location enables easy access from New Orleans to Jefferson Parish and its suburbs as well as the surrounding areas.

Kennedy's Child Care Academy was first established in July 2001 by its owners Anita and Theodore Kennedy, Sr. Unfortunately, Anita's husband of 32 years has recently deceased as of July 03, 2019. The first center was located in Orleans Parish at 6534 Maumus Ave. This facility was licensed for 27 children and offered before and after school services. Transportation services were geographically provided for the cities of Algiers, Gretna, Harvey, and Marrero. Business vastly increased and the owners began an expansion project; Kennedy's Child Care Academy II was founded in March 2005 Located in Jefferson Parish. As of today, there is only the center in Gretna after Hurricane Katrina damaged the building in Algiers. Although there are several child care centers in our geographic area, we continue to have a wait list.

Kennedy's Child Care Academy has an Early Head Start Program, partnership with Clover, formerly Kingsley House, providing 10-hour, year-round child care services for nearly 9 years. KCCA contracted with Birth-3 Program with Jefferson Parish School Board, Early Childhood Network to provide services for infants and toddlers up to 3 years of age. Unfortunately, due to funding source issues, the B-3 program ended only because the criteria of the program changed because funds were running out and all KCCA children were layered with CCAP funding.

Anita Kennedy, Owner/Executive Director of Kennedy's Child Care Academy has a Bachelor of Science Degree as a Health Educator from the University of New Orleans (UNO) with minor studies in childhood education. As a Health Educator, Anita acquired the knowledge of typical growth and development in young children. Anita is a PD Specialist with The Council for Professional Recognition and CPR Pediatric First Aid Instructor with the American Heart Association. Anita was formerly a CLASS Observer for Toddlers and Preschoolers. Anita has always had a commitment to higher education, therefore, when the 10,000 Small Businesses Program was offered in 2011, Anita applied and was admitted into the program to become among the first cohort graduates of 10,000 Small Businesses Program at Delgado Community College in New Orleans, LA.

Anita Kennedy is one of the founders of the Child Care Coalition, a Non-profit organization, to aid local Child Care Providers within Jefferson Parish.

Anita Kennedy is committed to professional membership in various organizations for the care of young children.

Program Policies for Parent's Responsibilities; Program Provides for the Parent:

Kennedy's Child Care Academy has an open door policy and parents and/or guardians are encouraged to visit and participate in the activities of the center. The Director and teachers provide written and verbal progress reports to the parents and/or guardians on the development of the children in our care. Parents are allowed time to ask questions or share concerns when every needed. The teachers and Director try very hard to give daily and/or weekly feedback on the children in our care to their parents and/or guardians. Parents are encouraged to participate in story time, field trips, special events for the center, and assist in the classrooms.

Family involvement and participation is very important for the growth and development of the children in our care. The Director and teachers share an open line of communication with all our parents and/or guardians. The Director and teachers are great at keeping the families informed about the children's stage of development. Parents are educated on the behaviors that can be expected at different levels of growth. Director and teachers communicate to the families the importance of socialization at all ages. Learning materials and favorite toys used by the children are shared with the parents to encourage continued development at home.
