

Section 1.0 – Pre-Bid Conference:

There will be no pre-bid meeting for this project. The bidder will be responsible for all measurements, etc. All site visits should be arranged through Gary Schmidt at (504) 736-6999 x89346 or email Gary at gschmidt@jeffparish.net.

Section 2.0 – Scope

We extend this bid to cover the removal of the existing fluorescent lamps, ballast, wiring, etc. in the damaged sign and convert to LED with new light sticks and power supplies.

Section 3.0 – License Requirement

All electrical work shall only be performed by local or state licensed electrician and all work shall meet all local, state and Federal codes.

Section 4.0 – Quantities/Inspection:

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project. All measurements given in these specifications are informational only.

Section 5.0 – Bid Specifications:

1. Remove existing fluorescent lamps, ballasts, wiring, etc. as needed and convert to LED with new light sticks and power supplies.
2. Bidder will manufacture two (2) new faces measuring approximately 45" by 8' with five (5) rows of 6" black changeable letters.
3. Bidder will repaint sign cabinet and pole with oil base industrial enamel paint.

4. Bidder will make one piece of damaged retainer approximately 5' long on one side of sign.
5. Bidder will install new faces into existing sign cabinet and supply 250 font of 6" letters.

Section 6.0 - Hours of Work:

Work shall be performed during normal working hours. All work must be scheduled with owner representative 5 days in advance. The successful bidder shall work normal building working hours (7:00am – 5:00pm) to provide a safe work environment at no extra charge to Jefferson Parish.

Section 7.0 – Cleaning Area and Safety:

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

Section 8.0 – Existing Structure

Should any cutting, patching, alteration, addition, or repairs to existing structure or fence be required of this project, the successful bidder shall restore the alteration to its original condition, with the same type materials, finish, and workmanship.

Section 9.0 – Warranty:

Five (5) years on the LED's

Section 10.0 – SDS:

The bidder shall notify the Jefferson Parish Department of General Services contact person of any hazardous substances that will be brought to and/or used at the workplace. The bidder shall provide SDS as per this requirement to the Director of the Jefferson Parish Department of General Services.

Section 11.0 – Permits:

The successful bidder shall obtain any and all permits required by the Jefferson Parish Department of Inspection and Code Enforcement and/or the City of Gretna. The successful bidder shall also be responsible for payment of these permits. All permits must be obtained prior to the start of the project.

Section 12.0 – Pre-Construction Conference and Notice to Proceed:

A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences. No work shall be performed until the successful bidder receives a written "Notice to Proceed" to begin work, from the Department of General Services.
