### **Section 1.0- Pre-Bid Conference:**

NO PRE-BID CONFERENCE IS NEEDED.

### **Section 2.0 Scope:**

#### **2025 Pre-Carnival Season, Carnival Season, and Post Carnival season (excluding Mardi Gras Day):**

Successful vendor must provide three (3) ambulances with two (2) crews, two (2) ASAP (Polaris) carts with two (2) crews, and (1) mule for medical coverage for the 2025 Carnival Parades on the Eastbank of Jefferson Parish. Included in this category are the following: Krewe of Little Rascals (Sunday 2/16/25), Family Gras Friday/Krewe of Excalibur (Friday 2/21/25, Family Gras Saturday/Krewe of Madhatter's (Saturday 2/22/25), Family Gras Sunday Krewe of Atlas (Sunday 2/23/25), Krewe of Symphony (Thursday 2/27/25) Krewe of Athena Sunday 3/2/25, Krewe of Centurions/Krewe of Kings (Monday 3/03/25), St. Patrick's Parade (3/16/25), Irish Italian Parade (3/23/25). Estimated number of hours for this category is 60 total hours.

#### **2025 Mardi Gras Day:**

Successful vendor must provide six (6) ambulances with two (2) crews, three (3) ASAP (Polaris) carts with two (2) crews, and (2) mules for medical coverage for the 2025 Carnival Parades on the Eastbank of Jefferson Parish. Included in this category are the following: Krewe of Argus, Krewe of Elks (Tuesday, 3/4/25). Estimated number of hours for this category is 10 total hours.

Ambulance unit must have two (2) providers: with at least one provider working at the ALS skilled paramedic level

ASAP Units (Polaris units) must have two (2) providers: with at least one provider working at the ALS skilled paramedic level.

Parade dates subject to change.

The EMS crews must arrive two (2) hours before the scheduled parade and coordinate with the Director of the Department of Citizens' Affairs on arrival location.

The EMS crews will be released per the EMS parade commander, once the event is over and the crowds have dispensed for safety purposes.

**Section 3.0 Operations:**

**Locations.** Locations shall be given per the EMS Parade Commander and the Director of the Department of Citizens' Affairs instructions.

**Hours.** FIRM shall maintain such hours as necessary to meet the requirements of this bid.

**Efficient and High-Quality Operation.** FIRM shall maintain an operation which is efficient and of a level of quality equal to or greater than industry standards.

**Products and Necessities.** FIRM shall furnish all working capital, services, inventory, personnel, materials, tools, machinery, equipment and other items necessary to perform FIRM's obligations under this Bid.

**Items.** FIRM shall not advertise its services rendered for Jefferson Parish without prior written consent of PARISH.

**Licenses and Permits.** FIRM shall obtain and keep at its own expense all federal, state and local licenses and permits required to be in its name in connection with this Bid.

**Compliance with Law, Rules and Regulation.** FIRM shall comply with all applicable laws, rules and regulations.

**Duty and Responsibilities.** FIRM owes to MANAGER a duty to perform FIRM'S obligation under this bid with integrity and good faith and in a manner that is in the best interests of the MANAGER and FIRM and consistent with the terms of this bid.

**Section 4.0 Financial Matters.**

**Operating Expenses.** FIRM is responsible for the payment of all operating expenses required as a result of providing services herein.

**Payments.** Services provided to PARISH by FIRM subject to this agreement shall be accompanied by detailed invoices fully describing and itemizing all charges and cost to be paid by PARISH. FIRM shall address and send invoice to the Department of Citizens' Affairs pursuant to the payment terms negotiated herein.

**Section 5.0 Personnel.**

**Employees.** FIRM shall employ, train and supervise personnel with appropriate qualifications and experience and in sufficient numbers to provide all services required under this Bid. All persons engaged by FIRM shall be the sole and exclusive employees of FIRM and shall be paid by FIRM. FIRM shall pay all applicable social security, unemployment, workers' compensation and other employment taxes.

**Appropriate Personnel.** FIRM shall provide only trained personnel. FIRM'S employees shall conduct themselves at all times in a proper and respectful manner in accordance with MANAGER's employee policy. If MANAGER determines that any employee of FIRM is unsatisfactory in any material respect, MANAGER shall request FIRM to exclude the employee or employees from work under this Bid, and FIRM shall so comply with such request.

**Non-Discrimination.** FIRM shall not discriminate against any employee or applicant for employment because of age, race, creed, sex, color national origin, or disability.

**Substitution of Personnel.** FIRM acknowledges that this Bid is contingent upon the personnel defined in FIRM's written proposal, and that if during the term of this Bid, FIRM is unable to provide those defined personnel, FIRM shall substitute personnel which shall meet or exceed the requirements stated herein and will be responsible for any payments to subcontractors.

**Independent Contractor.** While in the performance of services or carrying out the obligations under this Bid, FIRM shall be acting in the capacity of independent contractor and not as employee of PARISH, and not as partner of, or joint venture of PARISH. PARISH shall not be obliged to any person, firm or corporation for any obligations of FIRM arising from the performance of their services under this Bid

**Section 6.0 Tax Liability.** FIRM agrees to be responsible for and to pay all applicable federal income taxes, federal social security tax (or self-employment tax in lieu thereof) and any other applicable federal or state unemployment taxes.

FIRM agrees to indemnify and hold PARISH harmless from any and all federal and/or state income tax liability, including taxes, interest and penalties, resulting from PARISH'S treatment of FIRM as an independent contractor. FIRM further agrees to reimburse PARISH for any and all costs it incurs, including, but not limited to, accounting fees and legal fees, in defending itself against any such liability.

**Section 7.0 Insurance.** FIRM shall secure and maintain at its expense such insurance that will protect it, and PARISH, from claims under the Workmen's Compensation Acts and from claims for bodily injury, death or property damage which may arise from the performance of services under this Agreement. All certificates of insurance shall be furnished to PARISH and shall provide that insurance shall not be canceled without notice of cancellation given to the Parish of Jefferson, in writing, on all of the required coverage provided to Jefferson Parish. All notices will name FIRM, and identify the Council Resolution approving the terms of this Agreement. PARISH may examine the policies at any time and without notice.

All policies and certificates of insurance of the firm shall contain the following clauses: FIRM insurers will have no right of recovery or subrogation against PARISH, it being the intention of the PARTIES that the insurance policy so affected shall protect both PARTIES and be the primary coverage for any and all losses covered by the below described insurance.

PARISH shall be named as additional insured as regards to general liability and automobile liability with respect to negligence by FIRM.

The insurance company(ies) issuing the policy or policies shall have no recourse against PARISH for payment of any premiums or for assessments under any form of policy.

Any and all deductibles in the below described insurance policies shall be assumed by and be at the sole risk of FIRM.

Prior to the execution of this bid, FIRM shall provide at its own expense, proof of the following insurance coverage required by the contract to PARISH by insurance companies authorized to do business in the State of Louisiana. Insurance is to be placed with insurers with an A.M. Best Rating of no less than A:VI.

Commercial General Liability Insurance with a Combined Single Limit of at least \$1,000,000.00 per occurrence for bodily injury and property damage. This insurance shall include coverage for bodily injury and property damage.

Business Automobile Liability Insurance with a Combined Single Limit of \$1,000,000.00 per occurrence for bodily injury and property damage, unless otherwise indicated. This insurance shall include for bodily injury and property damage the following coverage.

All policies of insurance shall meet the requirements of PARISH prior to the commencing of any work. PARISH has the right but not the duty to approve all insurance policies prior to commencing of any work. If at any time any of the said policies shall be or becomes unsatisfactory to PARISH as to form or substance; or if a company issuing any such policy shall be or become unsatisfactory to PARISH, FIRM shall promptly obtain a new policy, submit the same to PARISH for approval and submit a certificate thereof as provided above.

**7.1 General.**

FIRM shall indemnify and hold harmless PARISH against any and all claims, demands, suits, costs, liabilities or judgments for sums of money, and fines or penalties asserted by any person, firm or organization for loss of life or injury or damages to person or property, to the extent caused by the negligent acts, errors, and/or omissions by FIRM, its agents, servants or employees, while engaged upon or in connection with the services required to be performed by FIRM under this Bid.

## **STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES**

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 136353 or No. 141125, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or her designee, with the concurrence of the Director of Risk Management or her designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. **Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date.** Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. **Failure to comply will cause the bid to be rejected.** The current insurance certificate will be used for proof of insurance at time of evaluation. Thereafter, and prior to contract execution, the low bidder will be required to provide final insurance certificates to the Parish which shall name **the Parish of Jefferson, its Districts Departments and Agencies under the direction of the Parish President and the Parish Council** as additional insureds regarding negligence by the contractor for the Commercial General Liability and the Comprehensive Automobile Liability policies. Additionally, said certificates should reflect the name of the Parish Department receiving goods and services and reference the respective Jefferson Parish bid number.

The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail. Quotations shall be based on F.O.B. Delivered, anywhere within the Parish as designated by the Purchasing Department. JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR. Items bid must meet specifications. JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection.
