Section 1.0 - Site Visits:

All prospective bidders can schedule a site visit thru Pat Bode with the Department of General Services between 8:30 a.m. to 4:30 p.m. Monday Thru Friday.

Section 2.0 – Scope:

We extend this proposal to cover the installation of a pure elastomeric silicone coating over the existing roofs of the Metairie Senior Center Building located at 265 N Causeway Blvd, Metairie, LA 70001. All preparation and installation shall follow manufacturer guidelines and instructions. See attachment “A” for the building location and areas of the top to be coated.

Line item 1:

Base bid:

All work described in these specifications to the lower roof, excluding sections nine (9) and ten (10) for ancillary work.

Line Item 2:

Alternate 1:

All work described in these specifications to the upper roof, excluding sections nine (9) and ten (10) for ancillary work.

Line Item 3:

Ancillary Work:

Provide a cost per square foot to remove, repair, and replace water-damaged roofing materials described in Section 10.0 of these specifications. This identified cost will not be part of the base bid and will not be used to determine the low bidder. This line item will only be used if needed.

Section 3.0 –License Requirements:

A Louisiana State Contractor’s License will be required in accordance with LSA R.S. 37-2150 et. seq., and such license number will be shown on the outside of the electronic bid envelope.

Failure to comply will cause the bid to be rejected. When submitting the bid electronically, the license number must be entered in the appropriate field in the electronic procurement system. Failure to comply will cause the bid to be rejected.” A copy of the license is not required by law;

Section 4.0 – Bonds:

- **Surety Bond:** An Electronic bid bond will be required with bid submission in the amount of 5% of the total bid. The vendor shall indicate the electronic bid bond number in the location specified on the electronic bid envelope. No scanned paper copies of any bid bond will be accepted as part of the electronic bid submission.
- **Performance Bond:** A Performance Bond in the amount of 100% of the total contract price will be required. The performance bond shall be produced upon contract execution.

Section 5.0 – Quantities/Inspection:

Bidders must inspect the site and perform their measurements to determine the proper quantity of labor, materials, and equipment required to complete this project.

Section 6.0 – Submittals:

If the bidder intends to provide materials equal to or better than owner-specified materials, the following shall be provided with the bid submission. Provide the requested information with your bid to ensure the bid is deemed responsive.

- Manufacturer's catalog data
- Detail sheets
- Specifications of product
- Warranty information

Section 7.0 – Bid Specifications:

- All materials shall be as specified new.
- All materials shall be applied as per all manufacturer recommendations and guidelines. See attachment "A" for the building location and roof areas to be coated.
- A field manager certified by the manufacturer of the product being applied, along with the owner, shall inspect the site and verify the work daily.

7.1 Before work begins:

- Successful bidder and an owner's representative shall inspect, document, and take photos of all existing building and roof conditions.
- Two weeks before installing new materials, an adhesion test shall be performed, and a typed written report shall be provided to the Department of General Services within seven days of completion of the test.

7.2 Preparation of Roof:

- Clean existing roof with Unisil cleaning concentrate agent and de-greaser.
- Prime existing roof with Unisil two-component, water-based primer.
- Seal all roof penetrations, splits, edge metal, and drains with Roof Mate Butter Grade water-based, high solid elastomeric sealant.
- Seal all roof penetrations, splits, edge metal, and drains with Roof Mate stitch-bonded, 100% polyester Fabric.

7.3 Application of Coating:

- Apply Unisil Roof Coating high volume solid, pure elastomeric silicone coating to the entire roof.
- Roof coating shall be applied per manufacturer recommendations and guidelines to achieve the twenty-year warranty required for this project successfully.
- Contrasting colors shall be used for each coat to ensure positive, uniform coverage. This also applies to the flashing membrane.
- Product manufacturer suggested drying time shall be allowed between coats.

Section 9.0 - Inferred Moisture Survey:

- Thirty Days before the start of the project, an infrared moisture survey shall be performed on the entire roof surface by a certified representative of the roof coating manufacturer.
- All areas of the roof shown to be wet shall be marked with yellow spray paint.
- On the same day the inferred scan is complete, all wet areas shall be verified using a pin-type moisture meter.
- For an accurate reading, the pins of the moisture meter shall be inserted through the granulated cap sheet and into the existing roof insulation.
- Five (5) days after the infrared moisture survey scan concludes, a standard drawing showing all wet areas and a typed written report listing all information noted during the survey shall be provided to the owner.

Section 10.0 – Remove, Repair, and Replace Water-Damaged Roofing Material:

- This work will only be used on an as-needed basis predicated on the results of the moisture test described in Section 9.0.
- Remove water-damaged area down to the metal roof deck
- Install new bidder-supplied insulation to match existing insulation.
- Thickness of new insulation shall match existing insulation.
- Fasten insulation with mechanical fasteners and deck mate screws.
- Apply a base sheet of SBS granulated membrane
- Prime with a top finish coat to match the existing roof membrane
- Apply a cap sheet to match the existing roof membrane

Section 11.0 - Hours of Work:

Work that shall not affect the normal operation of this facility can be scheduled during normal working hours Monday thru Friday, 7:00 a.m. – 4:00 p.m. Any work that may affect the facility's normal operation must be scheduled after normal working hours or on weekends.

Section 12.0 – Existing Structure

If the successful bidder should damage or destroy any part of a building, etc., the successful bidder shall be required to replace and restore said item to its original condition with the same type of material, finish, and workmanship at no additional cost to the owner.

Section 13.0 – Material and Workmanship Warranty:

All materials and workmanship shall have a twenty (20) year written warranty from the manufacturer.

A copy of all warranties shall be provided to the owner after the project.

All warranties shall commence after the project.

Section 14.0 – Safety Data Sheet (SDS):

The bidder shall notify the Jefferson Parish Department of General Services contact person of any hazardous substances brought to and used at the workplace. The bidder shall provide SDS per this requirement to the Jefferson Parish Department of General Services Director.

Section 15.0 – Liquidated Damages:

Commencing on the thirty-first (31) day, liquidated damages in the amount of \$300.00 will be assessed until work is substantially completed.

Section 16.0 – Start of Work Conference and Notice to Proceed:

A “Start of Work Conference” shall be held between the successful bidder and the owner before any work commences.

No work shall be performed until the successful bidder receives a written “Notice to Proceed” to begin work from the Department of General Services.

No materials shall be ordered until the successful bidder receives a written “Notice to Order” from the Department of General Services.


