Response: NEMA 3R switchgear is acceptable for this contract. NEMA 3R enclosures come in stainless steel, and are required on this project for corrosion protection.

2. Question: Is it the intent for the electrical contractor to install conduits (1" - 4") in the concrete slab or by a trapeze support system installed underneath the platform?

Response: The intent is for the electrical contractor to install conduits in the concrete slab for wiring to be pulled through.

3. Question: How high is the elevated platform for the Entergy furnished and installed transformer?

Response: The location and elevation of the elevated platform for the Energy equipment has not yet been determined. For bidding purposes, the top of this platform can be assumed at an elevation of +15'. This would match the elevation of the pump station platform.

4. Question: Can the bid date be extended?
