**LABOR, MATERIALS, AND EQUIPMENT NEEDED TO INSTALL NEW GUTTERS ON
THE GYM BUILDING AND INSTALL 26 GA PAINTED METAL FLASHING OVER
THREE (3) WINDOW SILLS LOCATED ON CONCRETE SLAB OVER GYM ENTRANCE

Section 1.0 – Pre-Bid Conference:

There will be no pre-bid meeting for this project. The bidder will be responsible for all measurements, etc. All site visits should be arranged through Brent Griffin, by calling the office at (504)349-5000 or his cellphone at (504) 419-4415.

Section 2.0 – Scope:

We extend this bid to cover all labor, materials and equipment to install new gutters on the gym building and install 26 GA painted metal flashing over 3 window sills located on concrete slab over gym entrance.

Section 3.0-License Requirements:

The following Louisiana State License shall be required for this project:

- LOUISIANA STATE COMMERCIAL LICENSE – BUILDING CONSTRUCTION

Section 4.0 – Quantities/Inspection:

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project. All measurements given in these specifications are informational only.

Section 5.0 – Scope of work:

The successful bidder shall supply all labor, materials, and necessary essentials to perform the following

- Demo existing gutter system
- Install 7" commercial seamless gutters on both sides of gym building
- Furnish and install twelve (12) 4" x 5" x 15' downspouts. (six (6) on each side on building)
- Owner to choose color
- Provide and install 26 GA painted metal flashing over three (3) window sill. (Windows located over concrete slab that is located over gym's front entrance doors.)
- Remove old caulking, clean and prep the three (3) window sills.

- Seal and caulk with manufacturer recommended sealant
- Pressure wash concrete slab which house A/C unit (located over gym's front entrance doors)
- Prep wall lower flashing by adding securement fasteners to secure flashing to concrete
- Furnish and install roof X tender 985 super silicone white roof coating system
 - 6" over the existing corrugated R-Panels and flashing extending 12" past end of flashing onto concrete slab
 - Install fleece membrane in-between coating layers to provide extended life to coating application
 - Process shall consist of first coat of grey and second coat of white
 - Total roof area to be covered is 40 SQ. feet
- Provide a lift as needed to complete the scope of work
- Provide all clean up and debris removal

Section 6.0 - Hours of Work:

Work shall be performed during normal working hours. All work must be scheduled with owner representative 5 days in advance. The successful bidder shall work normal building working hours (7:00am – 5:00pm) to provide a safe work environment at no extra charge to Jefferson Parish.

Section 7.0 – Cleaning Area and Safety:

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

Section 8.0 – Warranty:

A ten (10) year warranty in writing, from the date of notice to proceed, on all materials and workmanship shall be included. The bidder must agree, upon written notice from the owner, promptly and without charge, and to the satisfaction of the owner, to make changes, replacements, and corrections which may be required to make good all defects in materials and/or equipment under its intended use, within the warranty period, at no cost to the owner.

Section 9.0 – Existing Structure

Should any cutting, patching, alteration, addition, or repairs to existing structure, wall, floor, ceiling, or part of building be required of this project, the successful bidder shall restore the alteration to its original condition, with the same type materials, finish, and workmanship.

Section 10.0 – SDS:

The bidder shall notify the Jefferson Parish Department of Parks and Recreation contact person of any hazardous substances that will be brought to and/or used at the workplace. The successful bidder shall provide material safety data sheets MSDS as per this requirement to the Project Manager, Department of Parks and Recreation.

Section 11.0 – Permits:

The successful bidder shall obtain any and all permits required by the Jefferson Parish Department of Inspection and Code Enforcement. The successful bidder shall also be responsible for payment of these permits. All permits must be obtained prior to the start of the project.

Section 12.0 – Pre-Construction Conference and Notice to Proceed:

A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences. No work shall be performed until the successful bidder receives a written “Notice to Proceed” to begin work, from the Department of Parks and Recreation.

Section 13.0- Construction Term:

The successful bidder agrees that all work shall be completed within 30 days of issuance of Notice to Proceed.



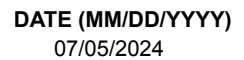
