Section 1.0 – Pre-Bid Conference:

Section 2.0 – Scope:

We extend this bid to cover all labor, materials, and necessary essentials to install thirty-one (31) Draper Techmatic Manual Window Shades at the Jefferson Parish Recreation Department Administrative Office 6921 Saints Drive, Metairie, LA 70003

Section 3.0 – Quantities/Inspection:

Bidders must inspect the site and perform their own measurements in order to complete this project. All measurements given in these specifications are informational only.

Section 4.0 – Bid Specifications:

The successful bidder shall supply all labor, materials and necessary essentials to perform the following at the Jefferson Parish Recreation Administrative Office:

- Install Thirty-One (31), 4' X 4' Interior Draper Techmatic Manual Window Shades or equal.
- Shade Fabric- Sheerweave Style Basic 5% fabric thickness, color to be selected by owner.
- Stainless Steel (standard) bead chain clutch operator- 10lb. High carbon steel and molded fiberglass reinforced polyester. White (standard) or black in color. Operator Location: Right hand (standard).

- Hem Bar- Kiln- Dried Maple Wood Slat (standard) inside of a 1 5/8" (30mm) pocket.
- End Caps- 1018 steel stamping. 3 3/8" X 3 7/8" (86 X 98mm) with fascia. Complete with roller mounting bracket. Installs to face, ceiling or jamb.
- End Cap Covers- Plastic covers snap onto endcaps. Available in ivory, bronze, black or white to match fascia.
- Fascia- "L" shaped cover of 6063-T5 extruded aluminum, .060 wall. Assembly snaps onto endcaps without exposed fasteners. Clear anodized finish (standard) or ivory, bronze, black or white powder coat. 3 3/8" X 3 7/8" (86 X 98 mm.)

Section 5.0 - Hours of Work:

Work shall be performed during normal working hours. All work must be scheduled with owner representative 5 days in advance. The successful bidder shall work normal building working hours (8:00am – 4:00pm) to provide a safe work environment at no extra charge to Jefferson Parish.

Section 6.0 – Cleaning Area and Safety:

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Area must be kept clean and free of material, equipment, and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

Section 7.0 – Warranty:

All workmanship and material to have one (1) year warranty and a ten (10) year manufactory warranty from the date of acceptance of the project. The bidder must agree, upon written notice from the owner, promptly and without charge, and to the satisfaction of the owner, to make changes, replacements, and corrections which may be required to make good all defects in materials and/or equipment under its intended use, within the warranty period, at no cost to the owner.

Section 8.0 – Pre-Construction Conference and Notice to Proceed:

A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences. No work shall be performed until the successful bidder receives a written “Notice to Proceed” to begin work, from the Department of Recreation.
