By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law as well be in compliance with the Jefferson Parish Code of Ordinances, Louisiana Code of Ethics, applicable Jefferson Parish ethical standards and Jefferson Parish Resolution No. 136353 and/or Resolution No. 141125 as amended.

Jefferson Parish adheres to the Louisiana Code of Governmental Ethics, contained in Louisiana Revised Statutes Annotated, R.S. 42:1101, et seq. Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law. Violation of the Louisiana Code of Governmental Ethics may result in rescission of contract, permit or licenses, and the imposition of fines and/or penalties, without contractual liability to the public in accordance with applicable law.

D. PRICES: Jefferson Parish is exempt from paying sales tax under LSA-R.S. 47:301 (8)(c). All prices for purchases by Jefferson Parish of supplies and materials shall be quoted in the unit of measure specified and unless otherwise specified, shall be exclusive of state and local taxes. The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail.

Quantities listed are for bidding purposes only. Actual requirements may be more or less than quantities listed.

Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. Furthermore, failure to attend the pre-bid conference and inspection does not relieve the successful bidder from the necessity of furnishing materials or performing any work that may be required to complete the work in accordance with the specification with no additional cost to the owner.

PURCHASE OF P3 CHLORINE SCALES

Section 1.0 - Scope:

We extend this bid to cover all materials, shipping and all other incidentals necessary to furnish new chlorine scales as listed in this bid.

Section 2.0 Submittals

Any bidder submitting bids other than that as specified shall be willing to provide, at the request of the parish, all specifications of the product they are bidding to fully demonstrate complete compliance with requirements of these specifications. The bid will be awarded to the lowest responsible bidder complying with all provisions of this invitation, providing the bid is reasonable, and in the best interest of Jefferson Parish to accept. Jefferson Parish reserves the right to accept or reject the bid in whole or part, any bids that are incomplete or do not demonstrate that they are equal to the requirements of these specifications. If additional info is requested by the parish, it shall be the bidder's responsibility to provide adequate information necessary for the complete evaluation of their proposed equipment and to visit the job site to confirm compliance of what is needed.

Section 3.0 – Bid Specifications:

A quantity of two (2) Force Flow or approved equal chlorine scales shall be provided and shall be of the digital readout/ electronic load cell type. The scale frame shall have a 2-part epoxy powder coat finish and be sized to accept six (6) 3,600 lb. chlorine ton containers. The scale frame shall have four (4) trunnion wheels per container to allow easy container rotation for valve alignment. Trunnion wheels shall be made of ultrahigh molecular weight polyethylene (UHMW-PE) with stainless steel axles. The scale frame shall be of such a size that it is within the dimensions of the containers it supports.

Scale length shall not exceed 200".

A digital indicator shall be provided for each scale and shall independently monitor the weight of the scale. The indicator shall have an alphanumeric LCD display, to allow the weight of the scale to be viewed. Indicator enclosure shall be NEMA 4X rated and UL approved. All operations shall be via a menu-driven keypad. Power requirement shall be 110/1/60.

A six-digit numerical display shall give operator the ability to monitor chlorine by weight or volume. A dual mode tare key shall allow user to enter the tare weight of the containers or enter the net weight of the chlorine, depending on application needs. A diagnostics menu shall allow system recalibration without the need for test weights. A user adjustable filter function shall stabilize weight display in the event of vibration from other co-located equipment.

Indicator shall output the net weight of scale via 4-20mA output for remote monitoring via PLC

or SCADA. Output span and trim shall be adjustable via the keypad.

Section 4.0 – Warranty:

Scale shall carry a Full Five (5) Year Factory Warranty. “Limited” Warranties shall be considered unacceptable. Full scale accuracy shall be better than 1/4 of 1%. Scale platforms shall be CHLOR-SCALE Model DR240 with SOLO G2 digital display Model SRG2-1 as manufactured from Force Flow or approved equal.

Where brand names are specified, it is for the purpose of establishing minimum standard of quality. Bids may be submitted for products for equal quality, provided the brand names are specified in the respective line items as indicated. Complete equivalent product data will be required upon request.






**6-TANK SCALE PLATFORM
