Qualifications/Experience

Waste Pro has been operating for more than 23 years and Waste Pro of Louisiana, Inc. is currently operating in solid waste collection, transportation and disposal and has been in existence for over 14 years. We are a Louisiana Business and have been operating at our corporate office in Kenner since 2010 – as evidenced by the LA Secretary of State Certificates of Good Standing and Existence provided in this proposal. Our LA DEQ SW Transporter Number is T-057-14291.

Waste Pro possesses the managerial and financial capabilities to perform all phases of the work called for in the RFP documents. Additionally, we have more than ninety (90) separate operating facilities including landfills in ten (10) regional market areas servicing more than two (2) million residential and one hundred thousand commercial (100,000) customers a month.

We are more than capable of providing the services under a resulting contract from this RFP. Our staffing strategy provides guarantees that there will be no service disruptions due to staff shortages. As a benefit of being partners with the New Orleans Saints, **the Saints will advertise our job fairs and we get to hold them at their facility during the Saints training camp.** This makes our job fairs very successful with hundreds of people participating! Our drivers work a 4-day work week with paid lunches. We moved to this strategy to allow our employees a better work and home life balance. We are over-staffed; we have more drivers than other companies in this industry because of our strategy – and IT WORKS. This strategy also allows us the ability to readily assist in emergent situations or storm events. Once called upon to assist, since our drivers and helpers work a 4-day work week, they are more than willing to work the extra day(s) to do whatever it takes to get the job done. Being over-staffed allows us to more than cover vacation, personal time off, sick leave and any other issues that effects staffing.

If selected, we will run this project out of our Kenner facility. We have the immediate support of our other Louisiana divisions in Baton Rouge, Geismar, Gibson, and Covington, if the need arises. Additionally, we own 4 Landfills (Ronaldson Field, Gator Debris Landfill & Recycling and KV Landfill) and operate another (Riverside Landfill).


