Unless otherwise specified, all workmanship and materials must have at least one (1) year guaranty, in writing, from the date of delivery and/or acceptance of the project. AWARD OF CONTRACT: JEFFERSON PARISH reserves the right to award contracts or place orders on a lump sum or individual item basis, or such combination, as shall in its judgment be in the best interest of JEFFERSON PARISH. Every contract or order shall be awarded to the LOWEST RESPONSIVE and RESPONSIBLE BIDDER, taking into consideration the CONFORMITY WITH THE SPECIFICATIONS and the DELIVERY AND/OR COMPLETION DATE. SPLIT AWARDS MADE TO SEVERAL VENDORS WILL ONLY BE GRANTED TO THOSE DEEMED RESPONSIVE AND RESPONSIBLE.

All bid prices shall remain valid for 45 days. Jefferson Parish and the lowest responsive and responsible bidder(s) by mutual written consent may mutually agree to extend the deadline for award by one (1) or more extensions of thirty (30) calendar days.

PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. Written protest must be received within 48 hours of the release of the bid tabulation by the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. (For more information, please see Chapter 2, Article VII, Division 2, Sec. 2-914.1 of the Jefferson Parish Code of Ordinances.)

PREFERENCE: Unless federal funding is directly spent by Jefferson Parish for this purchase, preference is hereby given to materials, supplies, and provisions produced, manufactured or grown in Louisiana, quality being equal to articles offered by competitors outside the state. "LSA - R.S. 38:2251-2261"

B. USE OF BRAND NAMES AND STOCK NUMBERS: Where brand names and stock numbers are specified, it is for the purpose of establishing certain minimum standards of quality. Bids may be submitted for products of equal quality, provided brand names and stock numbers are specified. Complete product data may be required prior to award.

C. CANCELLATION OF CONTRACT: JEFFERSON PARISH reserves the right to cancel all or any part if not shipped promptly. No charges will be allowed for parking or cartage unless specified in quotation. The order must not be filled at a higher price than quoted. JEFFERSON PARISH reserves the right to cancel any contract at anytime and for any reason by issuing a THIRTY (30) day written notice to the contractor.

For good cause and as consideration for executing a contract with Jefferson Parish, vendor conveys, sells, assigns and transfers to Jefferson Parish or its assigns all rights, title and interest in and to all causes of action it may now or hereafter acquire under the antitrust laws of the United States and the State of Louisiana, relating to the particular good or services purchased or acquired by Jefferson Parish.

D. PRICES: Jefferson Parish is exempt from paying sales tax under LSA-R.S. 47:301 (8)(c). All prices for purchases by Jefferson Parish of supplies and materials shall be quoted in the unit of measure specified and unless otherwise specified, shall be exclusive of state and local taxes. The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail.

Quantities listed are for bidding purposes only. Actual requirements may be more or less than quantities listed.

Bidders are not to exclude from participation in, deny the benefits of, or subject to discrimination under any program or activity, any person in the United States on the grounds of race, color, national origin, or sex; nor discriminate on the basis of age under the Age Discrimination Act of 1975, or with respect to an otherwise qualified handicapped individual as provided in Section 504 of the Rehabilitation Act of 1973, or on the basis of religion, except that any exemption from such prohibition against discrimination on the basis of religion as provided in the Civil Rights Act of 1964, or Title VI and VII of the Act of April 11, 1968, shall also apply. DESCRIPTION OF THE “MODERN JP” LOGO

The elongated JP mark is an abstract representation of the vertical shape of Jefferson Parish. The overlapping letters represent the East and West banks. The intersection of the two letters is the Mississippi River that connects the two banks together to unite both communities into one parish.

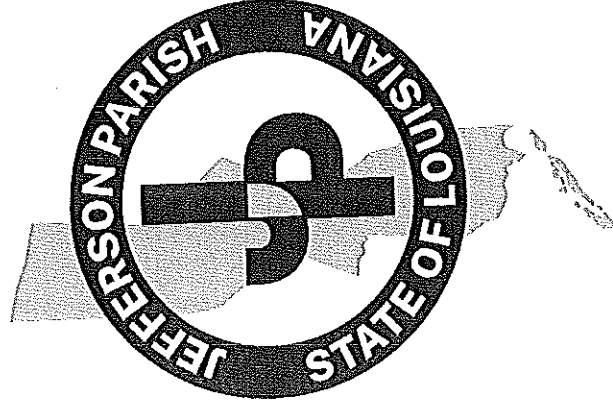

Pelican Emblem



The emblem incorporates the Brown Pelican (Louisiana's state bird) and the Huey P. Long Bridge, in an enclosure resembling a sunset over the water. The pelican represents strength, nobility, and beauty, while the bridge is a physical and iconic representation of the connection between the East and West banks of Jefferson Parish. The pelican is perched on the edge of the enclosure which is representative of the steadfast and resilient nature of the people of Jefferson Parish. It is looking to the right indicating forward progress and the future.

The Pelican Emblem **cannot** be used as a replacement for departments or anywhere the primary logo should be used. It is allowed on flags, t-shirts, stickers, hats, and other minor uses.



Seal



The Seal is an updated version of the previously existing Jefferson Parish seal. It incorporates an adaptation of the pelican motif from the Louisiana State Flag and is surrounded by rings of decorative flourishes in a circular enclosure.

The Seal may appear in 1 color only – Metallic Gold, Indigo, Black or White. The Seal is for documents, t-shirts, pins, signage and other official uses.

Color Palette

The Primary colors are Indigo and Blue. They are used in the Jefferson Parish logo, secondary mark, badge, and parts of the pelican emblem.

The Secondary colors are Gold and Orange. They are part of the pelican emblem. These colors can be used for supportive brand elements / campaigns / other creative, however, they should **never** be used in the Jefferson Parish logo, secondary mark, or badge.

The logo may appear in 1 or 2 color only. You may also use the logo in 100% black if printed in black/white or grayscale. On darker backgrounds, the logo can be white.

In process (four color) printing the colors are mixed by using different amounts of cyan, magenta, yellow and black - and can easily differ between printers and job runs. Included here are the values for the CMYK color employed in the logo and its color conversion to RGB, screen color (HEX) and PMS (Pantone Matching System).

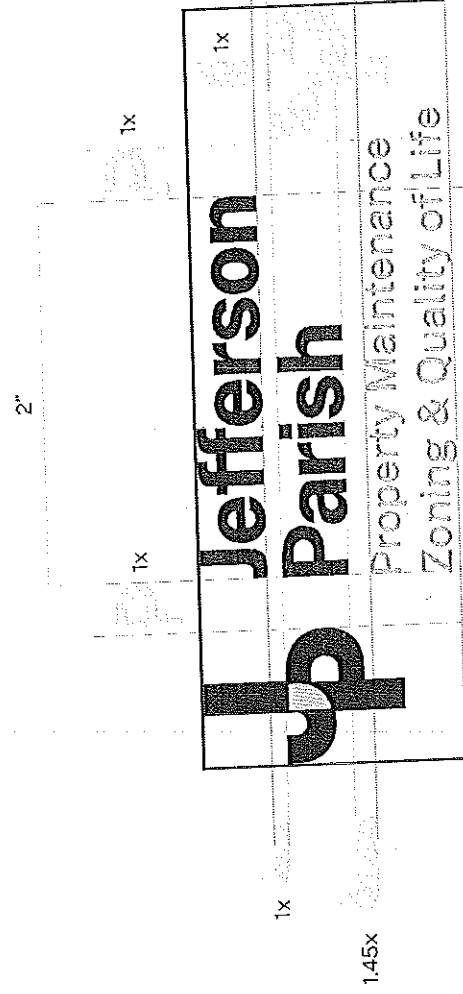
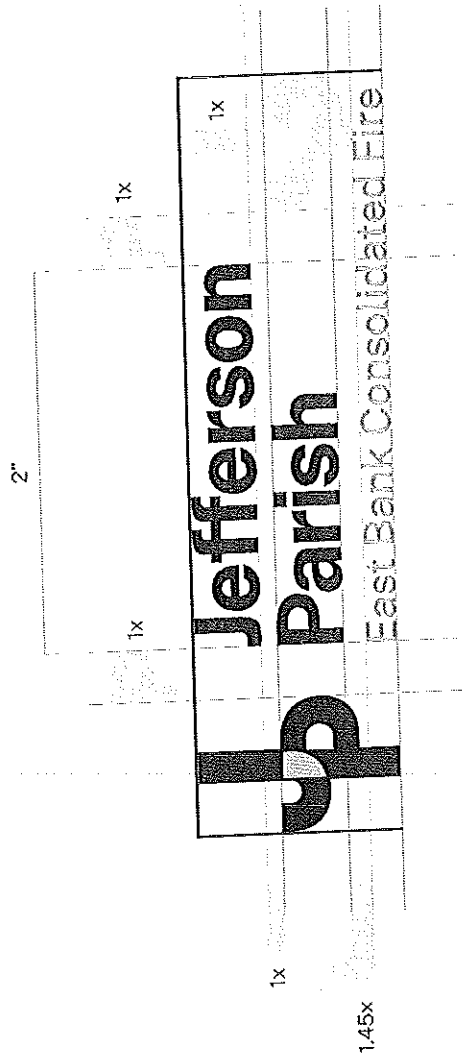
Department Logos

Red lines mark the outermost top, left, and right edges of the logo space. Department names should **not** exceed these borders.

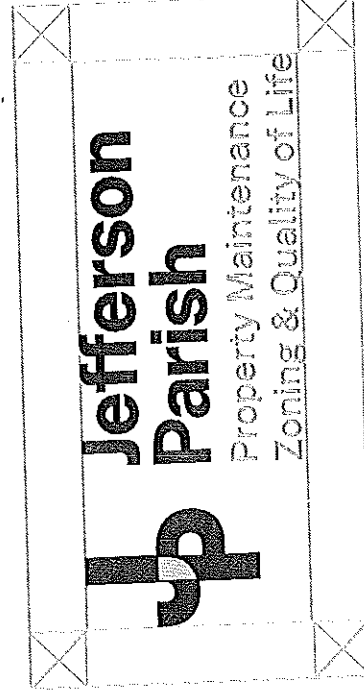
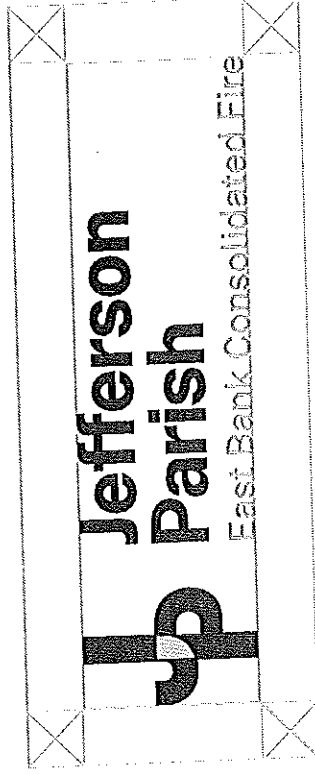
Longer names may be stacked on multiple lines as needed. Be mindful to dissect the words so as to not leave single words on a line (orphan). Sometimes this can't be avoided, but try to break the text in a meaningful way. A rule of thumb is to always maintain at least 2 words per line.

In this diagram, "Jefferson Parish" is 2 inches wide and the department name is 16pt font size with 19.2pt (auto) leading. When increasing or decreasing the size, be sure to scale it proportionally (height and width together) in order to keep the relational sizing between all the logo elements remain intact.

Once you've created a department logo, it is recommended to save a version with the text converted to outlines. The text becomes uneditable but is treated like a vector object/shape, which is better suited for scaling and printing.



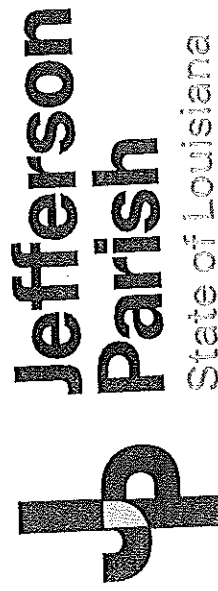
Clear Space



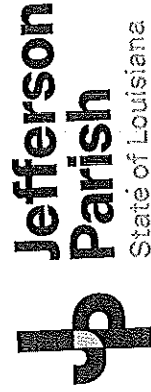
We've defined an exclusion zone that stops other graphic elements interfering with the logo and make sure it is easy to read. Proportions, space, and size relationships of all blocks have been carefully developed and must not be altered, redrawn, embellished or recreated in any way. An important part of maintaining a consistent presentation is keeping a clear space around the logo from other text, graphics or illustrations. Crowding the logo detracts from its legibility and impact.

From the outermost edges of the logo, measure approximately the length of one "P" in Parish around all sides.
