BIDS FOR SELF-LOCKING CORRUGATED F477 POLYETHYLENE PIPE

Sealed bids are invited and will be received by the Administrative Office of the Acadia Parish Police Jury, State of Louisiana, until Tuesday, May 15, 2012, at 1:00 P.M., in the Office of the Police Jury, **505 N.E. Court Circle, Administrative Office Building**, Crowley, Louisiana, for the purchase of the self-locking corrugated F477 polyethylene pipe requirements of the Parish for the period beginning July 1, 2012 through June 30, 2013.

SPECIFICATIONS:

Self-locking corrugated F477 polyethylene pipe shall have a smooth interior and annular exterior corrugations. Fifteen (15) to forty-eight (48) inch (300 to 1200 mm) shall meet AASHTO M294-97, type S. Fifty-four (54) and sixty (60) inch (1350 and 1500 mm) shall meet AASHTO MP7-97. Manning=s AN@ value for use in design shall not be less than 0.010.

Pipe shall be joined with the bell and spigot joint meeting AASHTO M252, AASHTO M294-97, MP7-97. The joint shall be silt tight and leak resistant. Gaskets shall be made of polyisoprene meeting the requirements of ASTM F477 with the addition that the gaskets shall not have any visible cracking when tested according to ASTM D1149 after 72 hour exposure in 50 PPHM ozone at 104N Fahrenheit. Gaskets shall be installed by the pipe manufacturer and covered with a removable wrap to ensure the gasket is free from debris. A joint lubricant supplied by the manufacturer shall be used on the gasket and bell during assembly.

Pipe and fitting material shall be high density polyethylene meeting ASTM D3350 minimum cell classification of 335420C for 15" through 60" diameters.

SPECIFICATIONS

For the furnishing diameter sizes 15", 18", 24", 30", 36", 42", 48", 54", 60" of self-locking corrugated F477 polyethylene pipe, F.O.B., plant or delivered in quantities to job site on public roads in Acadia Parish. Supplier shall be notified of delivery dates and amount to be delivered. Bids will be awarded on an item by item basis. Bidders may submit prices on all or any separate items. The Parish of Acadia is exempt from state and local sales and use tax.


