
Pursuant To "Louisiana Preference Law" Statute R.S. 39:1595,



The St. Martin Parish Government will receive sealed bids until 10:30 A.M. on Friday, July 6, 2012, at St. Martin Parish Courthouse Annex Building, 301 W. Port Street, St. Martinville, Louisiana 70582, for the purchase of Culverts and Pipes for a 12-month period.

All proposals must be submitted in a sealed envelope and clearly marked as "Call for Bid - Culverts and Pipes" on the outside of the envelope. No proposal will be accepted after 10:30 a.m. on July 6, 2012.

GENERAL REQUIREMENTS AND CONDITIONS

The bids will be awarded to the lowest responsible bidder meeting the requirements. St. Martin Parish Government does not guarantee any specific quantity to purchase. St. Martin Parish Government reserves the right to reject any bid.

St. Martin Parish Government reserves the right to terminate the contract with 48 hours written notice.

Prices quoted hereafter shall be firm for the contractual period and shall include delivery. St. Martin Parish Government is exempt from sales taxes. A sales tax exemption certificate will be furnished to all successful bidders.

Bidders shall attach a copy of their standard warranty.

St. Martin Parish Government will issue purchase orders for all orders as needed to the successful bidder. In no event shall items be delivered without prior authorization and a valid purchase order.

All items must be available and delivered within two (2) working days from the date of order. Should the contractor fail or refuse to deliver within this time frame, St. Martin Parish Government reserves the right to cancel its order and purchase the items on the open market. In the event the price on the open market is higher than the contract price, the contractor will be charged the difference between the contract price and the delivered price paid on the open market. Bidders will not be held liable for differences paid between the contract and the price on the open market if failure to deliver is due to a national emergency.

Invoices must reference the purchase order authorizing the acquisition. Invoices will be paid by St. Martin Parish Government within thirty(30) days from the date of receipt and acceptance of the order and invoice.
