

### TERMS AND CONDITIONS OF SALE AND DELIVERY

1. Quotations do not constitute a binding contract until accepted in writing and received in our office.
2. Settlement for barge deliveries shall be on the basis of our Barge Displacement weights, unless specified weights shall be requested by purchaser. Any expense incurred by such requests will be paid by purchaser.
3. Any tax or other charge imposed by State or Federal law upon the manufacture, sale, and/or transportation of the product herein specified, except fuel use taxes, shall be added to the price stated and paid by the buyer.
4. It is possible that accepted orders could be subject to delay caused by fire, flood, accidents, strikes, differences with employees, shortages of barges, embargoes, war, government action-civil or military, or any other cause interfering with production, transportation or delivery of the goods herein described, or any other contingency over which we have no control, and Pine Bluff Sand and Gravel Company shall not be liable for any damages resulting therefrom.
5. Any purchaser who is unable or unwilling to receive delivery according to agreement, and who wishes an extension of time to receive the undelivered portion thereof, shall thereby give the seller the right to cancel the agreement without penalty. Any delay covered by paragraph 4 on delivery, does not make the seller liable to fulfill the portion of the contract held up by such contingencies.

### TERMS OF SALE

1. All accounts are due within 30 days after delivery, unless otherwise agreed upon by the parties.
2. If, in the judgment of Pine Bluff Sand and Gravel Company, the credit of purchaser shall at any time become impaired, we have the right to decline to make further deliveries, except upon receipt of full payment for shipments already made plus full payment in advance for additional shipments or deliveries.
3. The terms and conditions of sale and delivery noted above will be in effect unless changes are approved in writing by Pine Bluff Sand and Gravel Company.
