


Figure 1: The Holly & Smith Process




Figure 2: 3-D Design Examples

TEAM ORGANIZATION




Figure 3: Organizational Chart

MANAGEMENT PLAN

Our management plan is rooted in a well-organized approach, as shown in Figure 1. During the program stage, we define space needs, analyze the site, and develop an opinion of cost based on current market conditions. This stage concludes with identifying the “big idea” to guide the project’s success. Throughout the process, we collaborate with stakeholders to ensure challenges identified at the program level are addressed, including updates to the cost opinion. We use digital tools like BIM 360 for real-time communication with design participants and employ a rigorous quality control process. Senior team members review architectural and consultant-level work to ensure cohesion, while an in-house specifications writer integrates with the Q/C process using E-Spec. During construction, we use a web-based tracking system for efficient document management. Our team visits the site weekly, requiring consultants to do the same, and we conduct monthly Owner/Architect/Contractor meetings to ensure coordination. We prioritize quick responses to submittals and RFIs, striving for a 10-day turnaround to maintain progress. Our proactive, teamwork-focused approach ensures a successful construction process and project outcome.
