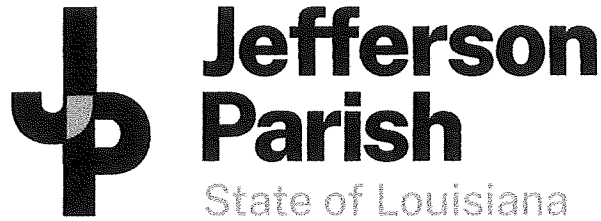

**Section 1.0 – Scope of Work:**

This contract shall include supply, temporary installation and removal of holiday themed pole decorations for a period of three (3) months. The rental pole decorations shall be temporarily installed and connected to the existing pole mounted electrical outlets located on the existing wood utility poles along Ames Boulevard in Marrero, LA.

The Contractor shall pick up and return Jefferson parish supplied pole decorations to at the Jefferson Parish Parkways Department located at 1887 Ames Boulevard, Building A.

**Section 2.0 – Project Site:**

The project site shall include the eastern right-of-way of Ames Boulevard between 4<sup>th</sup> Street and Barataria Boulevard in Marrero, Louisiana. The exact pole locations shall be marked in the field by Jefferson Parish.

**Section 3.0 –License Requirements:**

No State Contractor's license is required.

**Section 4.0 – Specifications:**

- This contract shall cover a period of three (3) months.
- All holiday decorations shall be installed prior to November 11, 2024.
- All holiday decorations must be removed between the following dates: January 13, 2025 and January 17, 2025.
- Prior to installing the rental pole decorations, the Contractor shall submit a list of proposed decorations for approval to Jefferson Parish. Color pictures and dimensions shall be included in the submittal.
- All supplied rental pole decorations shall be constructed of a powder coated steel, aluminum, stainless steel or galvanized steel frame. Each decoration shall include all required hardware, including lag screws, for temporarily mounting the unit to an existing wood utility pole.
- All supplied rental pole decorations shall include LED lighting operable by a standard 120V male plug connector. All LED lighting can be white, various colors or a combination of colors. All white LED lighting shall have a color temperature range from 3,000K to 4,000K. All supplied decorations must include similar color schemes between the fixtures.

- All supplied rental pole decorations shall have an average minimum dimension (height and width) of 5'-0". The decorations shall be of various 'holiday' designs including, but not limited to, snowflakes, stars, wreaths, trees, candy canes and ornaments. The maximum weight of each fully assembled decoration shall not exceed 50 lbs.
- All Jefferson Parish supplied pole decorations meet the above specifications.

**Section 5.0 – Schedule:**

All installation completed prior to November 11, 2024. Decorations shall be removed no earlier than January 13, 2025 and no later than January 17, 2025.

**Section 6.0 – Existing Site:**

All work shall take place along the eastern right-of-way of Ames Boulevard between 4<sup>th</sup> Street and Baratara Boulevard in Marrero, Louisiana. The site is accessible for viewing from the right-of-way at any time by prospective bidders. All prospective bidders are encouraged to visit the site.

**Section 7.0 – Site Access:**

The Contractor shall determine the best method of access to each utility pole. The Contractor shall access to each pole location via the Jefferson Parish right-of-way. The Contractor shall not be allowed to access private property unless he receives permission from the property owner. Any damage caused during installation shall be repaired at the Contractor's expense. The Contractor shall determine the best method to access his work. If any lane closures are required, the Contractor shall notify the Parkways Department a minimum of seventy-two (72) hours ahead of any proposed lane closures.

**Section 8.0 - Hours of Work:**

Work shall be performed during non-holiday weekdays between the hours of 7:00 am and 4:00 pm. Any work outside of these hours shall require prior approval from Jefferson Parish. The Contractor shall provide Jefferson Parish with a minimum twenty-four (24) hours of notice prior to the start of work. Once the installation is complete, the Contractor shall contact Jefferson Parish to schedule a final inspection of the work.

**Section 9 – Cleaning the Site and Safety:**

The job site must be clean and free of all litter and debris daily and upon completion of the contract. Remove any excess material and debris from each work location. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish and other Parish officials.

**Section 10 – Warranty:**

The Contractor shall ensure all of the decorations are operation throughout the installation dates.

**Section 11 – Pre-Construction Meeting and Notice to Proceed:**

A Pre-Construction Meeting will be conducted by Jefferson Parish prior to the issuance of the Notice to Proceed. At this meeting, the Parkways Department shall provide the proposed locations.

**Section 12 – Payment:**

Payment shall be made per each for all line items. Invoicing may occur upon completion of each line item.


