### **Section 1.0 – Site Visit:**

### **Section 2.0 – Scope:**

We extend this bid to cover all labor, materials, delivery, equipment, and all other incidentals necessary to paint and stripe the existing concrete parking lot at the Jefferson Parish Joseph S. Yenni Building located at 1221 Elmwood Park Blvd., Harahan, La. 70123.

### **Section 3.0 – License Requirements:**

A Louisiana State Contractor's License will be required in accordance with LSA R.S. 37-2150 et. seq., and such license number will be shown on the outside of the electronic bid envelope. Failure to comply will cause the bid to be rejected. When submitting the bid electronically, the license number must be entered in the appropriate field in the electronic procurement system. - All areas shall be painted using Sherwin Williams® Hotline fast-dry waterborne acrylic traffic paint.
- Parking lot striping, curbs, and ramp colors shall be painted with the brand colors listed below:
  - **Areas to be painted Sherwin Williams® Hotline fast dry waterborne acrylic Zone Yellow:**
    - Parking spaces
    - Curb marking
    - Directional symbols
  - **Areas to be painted Sherwin Williams® Hotline fast dry waterborne acrylic Handicapped Zone Blue:**
    - Handicapped spaces, handicap van accessible spaces, and handicap symbols.
  - **Areas to be painted Sherwin Williams® Hotline fast dry waterborne acrylic Zone White:**







