

## BID FORM

### BIDS FOR TRAFFIC CONTROL DEVICES & SIGNAGE MATERIAL

Sealed bids are invited and will be received by the Administrative Office of the Acadia Parish Police Jury, State of Louisiana, until Monday, May 13, 2013, at 1:30 P.M., in the office of the Police Jury, **505 N.E. Court Circle, Administrative Office Building**, Crowley, Louisiana, for the purchase of Traffic Control Devices & Signage Material for the period beginning July 1, 2013 through June 30, 2014.

#### SPECIFICATIONS:

A price must be quoted PER ONE EACH as stated delivered to the Road Department yard at 1528 West Second Street (Hwy. 90), Crowley, LA 70526. Prices quoted must be firm for a twelve (12) month period. Bidders must be capable of commencing delivery within seven (7) calendar days after receiving order. Successful bidder will be required to furnish operating license, insurance coverage, worker's compensation, etc if required by the Police Jury. All signs must conform to the latest requirements as set forth by the "MANUEL ON UNIFORM TRAFFIC CONTROL DEVICES". All roadway signs shall be made from .080 aluminum and **3M CO BRAND "PRISMATIC REFLECTIVE" SHEETING FOR BOTH EGR AND HI TYPE SIGNS**. Roadway signs will be standard word or symbol traffic control signs. All posts shall be steel of the flanged channel type and finished with deep green baked enamel. Holes measuring 3/8" in diameter shall be drilled or punched through the middle of each post on 1" centers for the entire length of each post.
