

BID BOND

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, Gray Construction Corporation as Principal (Bidder), and North American Specialty Insurance Company as Surety, are hereby held and firmly bound unto Vermilion Parish Police Jury as OWNER (Obligee), in the penal sum of Five percent of attached bid and alternates (5%) for payment of which sum well and truly to be made, the said Principal and the said Surety bind themselves, their heirs, executors, administrators, successors and assigns, jointly and severally, firmly by these presents.
