For more than fifteen (15) years the Firm has worked together to assist both nonprofit organization and local governmental entities with general civil litigation, construction litigation, disaster assistance managing Federal Public Assistance applications project designations, version request, Federal and State acquisition of funding, Hazard Mitigation (HM) grants designations and approvals, Alternative project designation and approvals, Disaster Pay Policy eligibility and reimbursements, Direct Administrative Costs, improved project designations and reimbursement, contract issues with those procured and construction related issues.

2. Experience and ability to provide the Parish of Jefferson with litigation experience

The governmental employees' testimony required interviewing witnesses and preparation of governmental employees to testify to issues related to parish ordinances, regulations, building codes, and FEMA public assistance policies.

The appeal and arbitration process for the projects listed in Appendix B requires our Firm to analyze large amounts of data, including cost analysis, parish or municipal ordinances, codes and standards, and to prepare the written appeal or arbitration. These often have thirty (30) day appeal or sixty (60) day arbitration deadlines that the Firm has never failed to meet.

4. The Firm's expertise

As set forth above, the Firm consists of the necessary personnel to conduct a thorough investigation of facts and procedures.
