This amount is agreed upon as the proper measure of the Liquidated Damage that the Owner will sustain per day, by failure of the undersigned to complete the contract, at the stipulated time, and is not to be construed, in any sense, as a penalty.

G. BOND

The undersigned agrees, if awarded the contract, to execute and deliver to the Owner at the time the contract documents are executed, a performance bond and a materials and labor bond in a form acceptable to the Owner, and in an amount equal to the contract sum. Failure to submit this bond at the time of the contract, or contracts, will cause forfeiture of bid security as liquidated damages.

H. BID SECURITY

The bid security attached in the sum of five percent (5%) of the Base Bid is to become the property of the Owner, as set forth in DIVISION 0, Section 00.117. Attached to this Proposal is Bid Bond, executed as required.


