These Standard Bid Clarifications shall be made a part of this bid and any subsequent Agreement issued pursuant to an award thereof.

These Bid Clarifications are not all-inclusive, and A-1 Elevator submits these Bid Clarifications with its bid with the understanding that the final Contract Documents, Terms, and Conditions are subject to review, further amendment, and approval by A-1 Elevator and shall not be binding until mutually agreed upon in writing by both parties.

1. Any obligations of A-1 Elevator to indemnify, defend and hold any Indemnified Party or Parties harmless shall be limited to A-1 Elevator's own acts, omissions, or negligence, and shall in no way include for the acts, omissions, or negligence of an Indemnified Party, or for bare allegations.
2. Sections 5.9, 6.0 and Addendum #1. It was noted during A-1 Elevator's site walk on Tuesday, October 22nd there are numerous deficiencies and code violations. For example, there are expired safety tests in multiple buildings. A comprehensive survey shall be conducted within 30 days of agreement ratification. Existing deficiencies shall be noted and presented to purchaser. Purchaser shall have the option to hold current vendor responsible for correction of deficiencies or authorize a separate repair order to remediate such deficiencies.
3. A-1 Elevator will not be required to make any changes or recommendations in the existing design or function of the unit(s). We shall not be obligated to service, make renewals or repairs upon the equipment by reason of obsolescence, misuse of the equipment, another's negligence, loss of power, blown fuse(s), tripped stop switch(es), theft, vandalism, explosion, fire, power failure, water damage, storm, lightning, nuisance calls, acts of civil or military authorities, strikes, lockouts, acts of God, or any other reason or cause beyond our control. In the event any component of the elevator becomes obsolete or outmoded, or is no longer manufactured by the original manufacturer, it shall be Purchaser's obligation to update the obsolete or outmoded component at Purchaser's expense. A-1 Elevator will not be obligated to install new attachments or parts upon the equipment as recommended or directed by insurance companies, any governmental agency or authority, or any third party.




