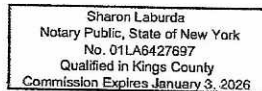



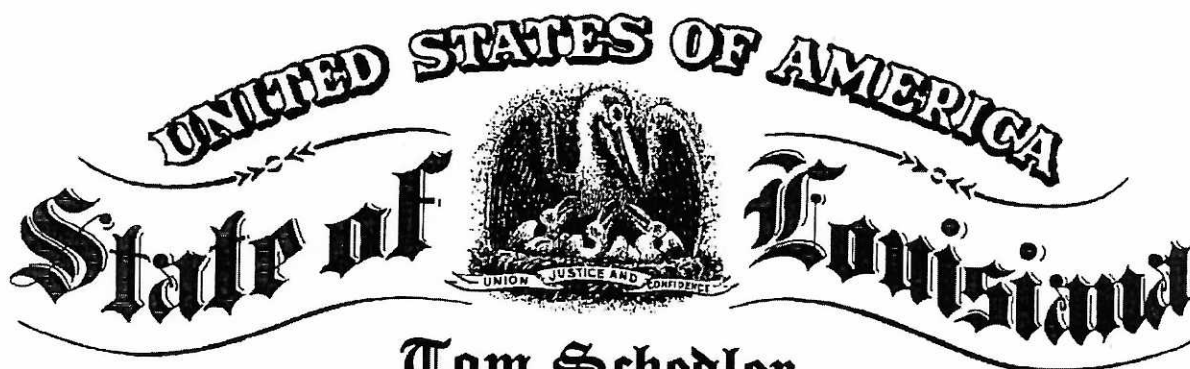

### **Powers of the Manager**


