Contract Terms:

A two (2) year contract for a supply of bronze fittings, for the Jefferson Parish Public Works Department of Water, all Water districts and all Jefferson Parish agencies and municipalities.

Warranty:

Products shall be warranted that they are manufactured in accordance with the applicable material specifications and are free from defects in workmanship and materials for one year after delivery. Any defective items sold under this contract shall be replaced at no cost to the purchaser.

General Specifications:

This specification is prepared for the acquisition of various types of bronze/brass fittings, which are used for waterline construction and maintenance by the Parish of Jefferson.

All pertinent technical specifications and literature may be required upon request. Should technical specifications and literature be requested, bidder(s) will be required to submit said technical specifications and literature within ten (10) days of the request.

All items in this bid must be of domestic United States manufacture and meet all criteria set forth by AWWA, ASTM, ANSI and federal and as specified hereafter.

Bidder must state the manufacture and model/catalog numbers of all items specified in this proposal.

The quantities shown on the proposal guide are approximate quantities to be acquired by Jefferson parish over a two (2) year period. Actual usage will be on an "as needed" basis.

Bid delivery shall include all freight and delivery costs to Jefferson Parish warehouse locations on the East and West Banks of Jefferson Parish.

Technical Specifications:

All bronze fittings shall be **low lead** brass and shall be made of heavy brass alloy 89833 per ASTM B62-09 and ASTM B584-09 (or latest revision) and shall meet or exceed AWWA C800-05 specifications with a 250 psi working pressure.

GROUP 1. Adapter (¾" To 2"):

Adapter shall be available in sizes of ¾" to 2". Adapter shall have an inlet of "pack joint" compression with clamping set screw, and an outlet of either female or male iron pipe. Adapter shall be made of heavy brass alloy 89833 per ASTM B62-09 and ASTM B584-09 (or latest revision) and shall meet or exceed AWWA C800-05 specifications with a 250 psi working pressure.

GROUP 2. Bushing (Brass Alloy) (Inlet ¾" To 2" ; Outlet ½" To 2"):

Bushings shall be of the reducing kind with an inlet of CC/AWWA male taper threads and outlets of female CC/AWWA taper threads. Bushings shall be made of heavy brass alloy 89833 per ASTM B62 and ASTM B584 and shall meet or exceed AWWA C800-05 specifications.

- **Bushing (Adapter):**

Bushing adapter shall be of the reducing kind with an inlet of CC/AWWA male taper threads and outlet of female national pipe threads.

GROUP 3. Connecters (Yoke Box Expansion):

Connector shall be made of heavy brass alloy 89833 per ASTM B62-09 and ASTM B584-05 and shall meet or exceed AWWA C800-05 specifications with a 250 psi working pressure. Connector yoke box expansion shall be standard/hand wheel and to have an inlet of female meter threads with an outlet of male yoke connection for a ⅝" x ¾" meter.

GROUP 4. Corporation Stops:

Corporation stops shall be made of heavy brass alloy per 89833 ASTM B62 and ASTM B584 and shall meet or exceed AWWA C800-05 specifications with a 250 psi working pressure.

- **Joint Compression Fitting (CC/AWWA):**

Corporation stop shall have an inlet of CC/AWWA male taper threads and an outlet of pack joint compression fitting with clamping set screw to have large raised rectangular keyway. Corporation stops shall be available in sizes from ¾" to 2".

- **Female Iron Pipe Threads (CC/AWWA):**

Corporation stop shall be with inlet of CC/AWWA male taper threads and outlet of female iron pipe threads, have large raised rectangular keyway, and range in sizes ¾" to 2".

GROUP 5. Meter Couplings:

Meter coupling shall be made of heavy brass alloy per 89833 ASTM B62 and ASTM B584 and shall meet or exceed AWWA C800 specifications with a 250 psi working pressure.

- **Female Iron Pipe Threading:**

Coupling meters shall have an inlet of female threaded meter nut coupler with an outlet of female iron pipe threading. Coupling meter shall be available in meters sizes of ¾", 1", and 2".

- **Male Iron Pipe Threading:**

Coupling meters shall have an inlet of female threaded meter nut coupler with an outlet of male iron pipe threading. Coupling meter shall be available in meter sizes of ¾", 1", and 2".

- **Oval Meter Flange (Female):**

Coupling meters shall have an inlet of oval meter flange and outlet of female iron pipe. Coupling meter shall be 2".

- **Oval Meter Flange (Male):**

Coupling meter shall have an inlet of oval meter flange and outlet of male iron pipe. Coupling meter shall be 2".

- **Oval Meter Flange (Pack Joint Compression):**

Coupling meters shall be oval meter flange with an outlet of pack joint compression type fitting with clamping set screw and shall be available in 2".

- **Pack Joint Compression (Female):**

Coupling meters shall have an inlet of female threaded meter nut coupler with an outlet of pack joint compression type fitting with clamping set screw. Coupling meter shall be available in sizes of ¾" to 2".

- **Pack Joint Compression (Male):**

Coupling meters shall have an inlet of male threaded meter nut coupler with an outlet of pack joint compression type fitting with clamping set screw. Coupling meter shall be available in sizes of ¾" to 2".

GROUP 6. Coupling Union:

Coupling union shall be made of heavy brass alloy 89833 per ASTM B62 and ASTM B584 and shall meet or exceed AWWA C800-05 specifications with a 250 psi working pressure. Coupling union shall have an inlet and outlet of "pack joint" compression with clamping set screw. Coupling union shall be available in sizes ranging from ¾" to 2".

- **Coupling (Reducer):**

Coupling union (reducer) shall have an inlet and outlet "pack joint" compression with clamping set screw with ¾" PJ on one end and 1" PJ on the other.

- **Coupling/Adapter:**

Coupling/adapter shall be an inlet of "pack joint" compression fitting with clamp set screw for PE tubing, and an outlet of "pack joint" compression fitting with clamping set screw and gasket for IP pipe.

- **Union/Adapter:**

Coupling (union/adapter) shall be an inlet of "pack joint" compression fitting with clamping set screw and gasket for PE tubing, and an outlet of "pack joint" compression fitting with clamping set screw and gasket for IP pipe. Couplings (union/adapter) shall be available in sizes ¾", 1", and 2".

GROUP 7. Curb Stop Ball Valves:

Curb stop ball valve shall be made of heavy brass alloy 89833 per ASTM B62 and ASTM B584 and shall meet or exceed AWWA C800-05 specifications with a 250 psi working pressure.

- **Female Iron Pipe Threads (Inlet/Outlet):**

Curb stop ball valve shall have an inlet and outlet of female iron pipe threads and to have large raised rectangular key way with pad lock wings. Available sizes shall be ¾", 1", and 2".

- **Pack Joint Compression Type:**
Curb stop ball valve shall have an inlet and outlet of pack joint compression type fitting with clamping set screw and to have large raised rectangular key way with padlock wings. Available sizes shall be ¾", 1", and 2".
- **Pack Joint Compression Type Inlet:**
Curb stop ball valve shall have an inlet of pack joint compression type fitting with clamping set screw and an outlet of female iron pipe. Curb stop ball shall have large raised rectangular key way with padlock wings.

GROUP 8. Ell Couplings:

Ell couplings shall be made of heavy brass alloy 89833 per ASTM B62 and ASTM B584 and shall meet or exceed AWWA C800-05 specifications with a 250 psi working pressure. Ells shall have an inlet and outlet of "pack joint" compression with clamping set screw with available sizes of ¾", 1", and 2".

- **Ell Coupling (Adapter):**
Ell coupling (adapter) shall have an inlet of "pack joint" compression with clamping set screw and an outlet of female iron pipe. Ell (adapter) shall also be available with an outlet of male iron pipe. Available sizes shall be ¾", 1", and 2".
- **Ell Meter:**
Ell meter shall have an inlet of threaded meter nut coupler with an outlet of female iron pipe. Ell meter shall also be available with an outlet of male iron pipe and "pack joint" compression with clamping set screw. Available sizes shall fit ¾" and 1" meters.

GROUP 9. Nut Pack Joints:

Nut pack joints shall be made of heavy brass alloy 89833 per ASTM B62 and ASTM B584 and shall meet or exceed AWWA C800-05 specifications with a 250 psi working pressure. Nut shall be fit a pack joint with clamping set screw and gasket. Available sizes shall be ¾", 1", and 2".

GROUP 10. Brass Plugs:

Brass plug shall be made of heavy brass alloy 89833 per ASTM B62 and ASTM B584 and shall meet or exceed AWWA C800-05 specifications with a 250 psi working pressure. Brass plug shall have inlet of CC/AWWA male taper threads and shall have a raised square wrench head nut. Available sizes shall be ¾", 1", and 2" male CC.

GROUP 11. Tees (Pack Joint Compression Type):

Tee shall be made of heavy brass alloy 89833 per ASTM B62 and ASTM B584 and shall meet or exceed AWWA C800-05 specifications with a 250 psi working pressure. Tee inlet "run" and outlet "branch" shall be of "pack joint compression type fitting with clamping set screw. Available sizes for "run" and "branch" shall be ¾", 1", and 2" PJ.

- **Tee (Multi Service):**

Tee shall have an inlet of female iron pipe and outlet of six (6) female iron pipe, with 1-2" FIP (bottom) x 6-1" FIP (perimeter).

GROUP 12. Meter Ball Valves:

Valve meter ball valve shall be made of heavy brass alloy 89833 per ASTM B62 and ASTM B584 and shall meet or exceed AWWA C800-05 specifications with a 250 psi working pressure. Valve meter ball valve shall have an inlet of pack joint compression type fitting with clamping set screw and outlet of female meter nut coupler with a raised rectangular key way with padlock wings. Ball valve shall be available for meter sizes of ¾", 1", and 2".

- **Meter Ball Valve (90°):**

Valve meter ball valve (90°) shall have an inlet of pack joint compression type fitting with clamping set screw and outlet of female meter nut coupler with a raised rectangular key way with padlock wings. Ball valve shall be available for meter sizes of ¾", 1", and 2".

GROUP 13. Wyes:

All wyes shall be bronze and conform to AWWA standard C800-05 (ASTM B-62 and ASTM B-584)

- **Multi-Service Wyes (FIP X 4-FIP):**

Wyes shall have an inlet of female iron pipe and outlets of female iron pipe. Size of inlet shall be 2" and the size of the outlets shall be 1".

- **Wye (2-MIP x MIP):**

Wyes shall have two inlets of male iron pipe and an outlet of male iron pipe. Size of the inlets shall be ¾" and the outlet shall be 1".

- **Wye (PJ x 2-PJ):**

Wyes shall have an inlet and two outlets of pack joint compression type fitting with clamping set screw. Size of the inlet shall be 1" and the outlets shall be ¾".

GROUP 14. Blind Gaskets:

Blind gasket shall be made of vulcanized fiber material for use in potable water. Gaskets shall be available to fit ¾" and 1" meters.

- **Blind Gasket (3/4" Meter):**
Blind gasket shall be made of vulcanized fiber material for use in potable water. Dimensions shall be 1-5/32" OD by 1/16" thick.
- **Blind Gaskets (1" Meter):**
Blind gasket shall be made of vulcanized fiber material for use in potable water. Dimensions shall be 1-1/2" OD by 1/16" thick.

GROUP 15. Gasket Rings:

- **Gasket Rings (Fiber-3/4" Meter):**
Gasket ring shall be made of vulcanized fiber material for use on potable water. Dimensions shall be 1-5/32" OD by 23/32" ID by 1/6" thick.
- **Gasket Rings (Fiber-1" Meter):**
Gasket ring shall be made of vulcanized fiber material for use on potable water. Dimensions shall be 1-1/2" OD by 1" ID by 1/16" thick.
- **Gasket Rings (3/4" Meter Coupling):**
Gasket ring shall be made of vulcanized fiber material for use on potable water. Dimensions shall be 1-5/32" OD by 25/32" by 1/8" thick.
- **Gasket Rings (1" Meter Coupling):**
Gasket ring shall be made of vulcanized fiber material for use on potable water. Dimensions shall be 1-1/2" by 1" ID by 1/8" thick.
- **Gasket Rings (3/4" Yoke Box):**
Gasket ring for a 3/4" yoke box expansion connector shall be made of neoprene material for use on potable water. Dimensions shall be 1-11/32" OD by 26/32" ID by 1/8" thick.

GROUP 16. Gasket Drop Ins For 2" Flanged (Oval) Water Meter:

Drop in gasket shall be made of two-ply neoprene material for use on potable water. Dimensions shall be 3-15/16" OD by 2-1/4" ID by 1/8" thick with ears to set on top of flange bolts.

GROUP 17. Bushings (Domestic Bronze):

Bushing shall be domestic bronze fittings to meet or exceed ANSI B16.15, ANSI B2.1, and fed. WW-P-460 for 125 pound threaded fittings to be air tested under water.

- **Bushings (1" x 3/4"):**
Bushing shall have an inlet of male iron pipe thread and an outlet of female iron pipe thread.

- **Bushings (2"x 1"):**
Bushings shall have an inlet of male iron pipe thread and an outlet of female iron pipe thread.

GROUP 18. Caps (Female Iron Pipe Thread):

Caps shall be domestic bronze fittings to meet or exceed ANSI B16.15, ANSI B2.1, and fed. Ww-p-460 for 125 pound threaded fittings to be air tested under water. Available sizes shall be ¾", 1", and 2".

GROUP 19. Couplings (Female Iron Pipe Thread):

Couplings shall be domestic bronze fittings to meet or exceed ANSI B16.15, ANSI B2.1, and fed. WW-P-460 for 125 pound threaded fittings to be air tested under water. Available sizes shall be ¾", 1", and 2".

GROUP 20. Crosses (Female Iron Pipe Thread):

Crosses shall be domestic bronze fittings to meet or exceed ANSI B16.15, ANSI B2.1, and fed. WW-P-460 for 125 pound threaded fittings to be air tested under water. Available sizes shall be ¾", 1", and 2".

GROUP 21. Elbows (Female Iron Pipe Thread):

Elbows shall be domestic bronze fittings to meet or exceed ANSI B16.15, ANSI B2.1, and fed. WW-P-460 for 125 pound threaded fittings to be air tested under water. Elbows shall be available in 45° and 90° bends. Available sizes shall be ¾", 1", and 2".

- **Street Elbows (Female Iron Pipe Thread):**

Street elbow shall have female iron pipe thread on one end and male iron pipe on the other. Elbows shall be available in 45° and 90° bends. Available sizes shall be ¾", 1", and 2".

GROUP 22. Nipples:

Nipples shall be domestic bronze fittings to meet or exceed ANSI B16.15, ANSI B2.1, and fed. WW-P-460 for 125 pound threaded fittings to be air tested under water. Nipples shall be available in all male iron pipe thread. Available in sizes close, ¾", 1", 2", 3", and 4".

GROUP 23. Reducers:

Reducers shall be domestic bronze fittings to meet or exceed ANSI B16.15, ANSI B2.1, and fed. WW-P-460 for 125 pound threaded fittings to be air tested under water. Reducers shall be available in all female iron pipe thread. Available sizes shall be ¾", 1", and 2".

GROUP 24. Tees (Female Iron Pipe Threads):

Tees shall be domestic bronze fittings to meet or exceed ANSI B16.15, ANSI B2.1, and fed. WW-P-460 for 125 pound threaded fittings to be air tested under water. Tees shall be available in all female iron pipe thread. Available sizes shall be $\frac{3}{4}$ ", 1", and 2".

GROUP 25. Unions:

Unions shall be domestic bronze fittings to meet or exceed ANSI B16.15, ANSI B2.1, and fed. WW-P-460 for 125 pound threaded fittings to be air tested under water. Unions shall be available in all female iron pipe threads. Available sizes shall be $\frac{3}{4}$ ", 1", and 2".

Jefferson Parish adheres to the Louisiana Code of Governmental Ethics, contained in Louisiana Revised Statutes Annotated, R.S. 42:1101, et seq. Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law. Violation of the Louisiana Code of Governmental Ethics may result in rescission of contract, permit or licenses, and the imposition of fines and/or penalties, without contractual liability to the public in accordance with applicable law.

JEFFERSON PARISH requires all products to be new (current) and all work must be performed according to standard practices for the project. Unless otherwise specified, no aftermarket parts will be accepted. Unless otherwise specified, all workmanship and materials must have at least one (1) year guaranty, in writing, from the date of delivery and/or acceptance of the project. Any deviations or alterations from the specifications must be indicated and/or supporting documentation supplied with bid submission.

Bidders should submit all questions in writing via email to the Purchasing Specialist's email address as indicated above, no later than Five (5) working days prior to the bid opening.
