

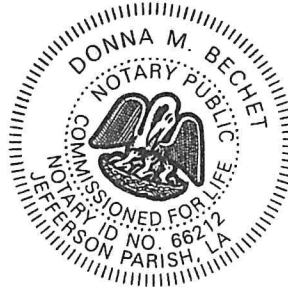



1. The preparing, approving, or failing to prepare or approve, maps, shop drawings, opinions, reports, surveys, field orders, change orders or drawings and specifications; or
  2. Supervisory, inspection, architectural or engineering activities.

All other terms, conditions and exclusions under the policy are applicable to this Endorsement and remain unchanged.
