SPECIFICATIONS (GENERAL)

Specifications for gravel shall conform to the following:

Washed or screened gravel shall consist of hard, durable particles of stone graded from course to fine; reasonably free of sticks and other deleterious matter, and when tested in accordance with AASHTO designation T-27 of the testing procedure manual shall meet the following requirements:

1-1/2"	95 - 100
No. 4	0 - 15

Clay & Silt (by AASHTO T 11) 2% Maximum

Specifications for crushed limestone and crushed sandstone shall conform to the following:

The material shall be 100% crushed limestone or 100% crushed sandstone and shall show not more than 45 per cent loss when tested in accordance with AASHTO designation T 96; and shall show not more than 15 per cent loss when tested in accordance with AASHTO designation T 104; and shall meet the following gradation requirements:

Each bid must show complete specifications if different than specified herein. The Atchafalaya Basin Levee District reserves the right to accept or reject any or all bids and the right to decide tie bids.

METHOD OF MEASUREMENT FOR PAY QUANTITIES:

Payment shall be by the cubic yard truck measurement or by truck weights. The weighing facility shall be capable of stamping the net weight of material delivered directly on the delivery ticket. No hand-written weights will be accepted. Conversion of weight measures to cubic yards shall be at the rate of 2700 lbs. per cubic yards for Gravel, 3000 lbs. per cubic yard for Crushed Limestone, and 2800 lbs. per cubic yard for Crushed Sandstone. It will be required to specify whether a bid is by the cubic yard or ton. Bidder will be required to furnish a one year bid bond with his bid in an amount of \$200.00 for each bid submitted. In case a bidder is unsuccessful, the bid bond shall be returned within 30 days. The low bidder's bond shall be kept by the Atchafalaya Basin Levee District to provide assurance that bidder shall be responsible to deliver according to his low bid. The bid bond shall be either cash, cashier's check, money order, or a bond from a bonding firm. Bidder shall be required to start delivery of material within 5 working days of official notice from the Atchafalaya Basin Levee District to deliver the requested material and shall diligently pursue the delivery of the requested amount within 10 calendar days.
