BASE BID: For all work required by the Bidding Documents (including any and all unit prices but not alternates) the sum of:

- 1) Install New Chiller Pad with 2 100 tons chillers & 2 pumps + Controls
- 2) Remove/Demolish all DX Split systems and replace with chilled water Fan Coils and AHUs as indicated
- 3) Install fan coils in all classrooms and bathrooms with independent Tstats per room.
- 4) Replace 2 Boilers with new. Match equal capacities. Replace all Boilers' Pumps
- 5) Remove/Abate asbestos pipe insulations and replace as specified.
- 6) Remove/replace all Hot Water, CWS & CWR piping as indicated. Run all pipes over canopy.
- 7) Add dedicated fresh air AHUs in hallways for fresh air. Supply all necessary controls and VAV boxes with CO2 sensors. Mount in attic space and build up ceiling space as required to cover AHUs
- 8) Incorporate Siemens Controls with all of the existing Tstats and exterior controls.
- 9) Incorporate all SDs and controls with the existing analogue fire alarm system as required by NFPA, Fire Marshal and applicable codes (provide shut down during fire alarms etc.)
- 10) Run all new piping underground whenever possible.
- 11) Add new 480 V service for the chiller pad area.
- 12) Remove all unused wires back to source. Cap all unused piping that remains underground.
- 13) Concrete pad for HVAC equipment
- 14) Wooden fence for concrete pad

Work has to be phased out on a building by building basis as per client's request.

Also, add 10% Contingency to total bid amount.

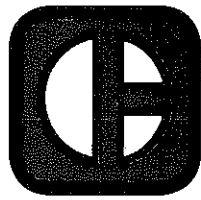



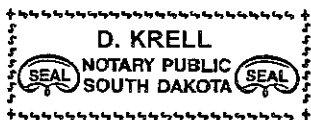
