## **SPECIFICATION REMOTE RACKING SYSTEM**

### **1.0 SCOPE**

This specification defines the technical requirements for the purchase of a remote racking device(s) for various brands and models of medium and low voltage switchgear for Jefferson Parish Water Treatment. A universal remote racking device is defined for this specification as a circuit breaker racking system which allows a medium or low voltage circuit breaker to be installed or removed from the supply and load bus stabs remotely, in an effort to reduce the potential of personnel injury should a breaker failure or arc flash occur.

### **2.0 GENERAL**

- 2.1 This solicitation is in response to the need for remote racking devices for various manufacturers' switchgear.
- 2.2 The intent of this solicitation is to procure sufficient remote racking hardware such that all station 480-38kV switchgear style breakers can be remotely racked in and out of the service position.
- 2.3 The remote racking system shall be fully automatic and capable of performing the complete racking operation, including actuation of interlocks, without manual human intervention. Reference charts and/or manual adjustment are not allowed.

### **3.0 STANDARDS:**

- 3.1 The equipment components shall be designed and manufactured in accordance with the latest revisions of the following codes and standards:
  - 3.1.1 National Electric Code (NEC)
  - 3.1.2 American National Standards Institute (ANSI)
  - 3.1.3 National Fire Protection Agency (NFPA)
  - 3.1.4 Underwriters Laboratory (UL)
  - 3.1.5 Institute of Electrical and Electronics Engineers, Inc. (IEEE)
  - 3.1.6 National Electrical Manufacturers Association (NEMA)

## **4.0 PHYSICAL REQUIREMENTS**

- 4.1 All hardware associated with manufacture of the racking device
- 4.2 Vertical positioning of the remote racking system motor shall be motorized. The operator shall accomplish any position adjustments by touch screen control.
- 4.3 The remote racking system shall work without modifications to the circuit breaker, circuit breaker door or cubicle.
- 4.4 The system shall have tethered or wireless remote capability for a minimum of 75 feet from the racking operation.
- 4.5 The remote racking system shall be equipped with the necessary breaker connection tooling accessories to perform racking operations based on the breaker list provided.
- 4.6 The remote racking system shall be constructed to remain stationary during the racking process and not require any type of bungee cord or magnetic connection to the switchgear for the motor to stay connected to the circuit breaker as it travels.
- 4.7 The remote racking system motor shall be spring assisted in order to maintain engagement between the racking device and subject circuit breaker. The spring assistance shall also allow operation of certain passive interlocks that are built into the mechanism once the device is connected to the breaker.
- 4.8 All tires shall be flat free type. Pneumatic tires are not acceptable.
- 4.9 The remote racking system shall be controlled using a variable frequency drive which shall reduce the racking speed prior to reaching the fully connected or disconnected position. Clutch systems are not allowed as a means of torque control. The motor must utilize brushless DC design.
- 4.10 The remote racking system must be able to monitor and display real time torque and turn count real time during the racking operation.

- 4.11 The remote racking system must be able to graph and display motor speed, turn count and torque measurements encountered during the racking operation.
- 4.12 The remote racking system must be able to apply variable torque; applying higher torque entering the connect position, applying minimal torque at the disconnect position and applying only the necessary torque between the connect and disconnect positions without interruption of the racking sequence.

## **5.0 ELECTRICAL REQUIREMENTS**

- 5.1 Power Supply - System must be capable of operating under the following power requirements:
  - a. 120 VAC - 60 Hz
  - b. 120 VAC - 50 Hz
  - c. 220 VAC - 60 Hz
  - d. 220 VAC - 50 Hz
- 5.2 The remote racking system must be capable of notifying the operator of a loss of power condition and assist the operator to complete the racking operation after a loss of power event.
- 5.3 If battery powered, the racking system must notify the operator when the batteries are low and require charge, and allow a completed racking operation before shutting down on low power.
- 5.4 If battery powered, the racking system must operate normally when “shore” power is applied. Wait time for charge before use is unacceptable.
- 5.5 If battery powered, constant battery voltage monitoring must be provided to show the level of charge associated with the battery system any time the system is running on battery backup power.

## **6.0 TORQUE MONITORING SYSTEM**

- 6.1 The racking unit must be able to measure and control based on foot-pounds of torque.
- 6.2 The racking system shall have programmable torque monitoring and limiting capabilities.
- 6.3 Protection based on measuring “amps” of the racking motor is not acceptable.
- 6.4 Torque monitoring and limiting must be adjustable with at least three (3) set points while racking a circuit breaker.
- 6.5 Adjustable, mechanical shaft clutch systems are not acceptable.

## **7.0 OPERATION REQUIREMENTS**

- 7.1 Remote racking system should be capable of racking out breakers from various manufacturers and a variety of models with the exchange of fittings/tooling provided with the assembly.
- 7.2 The remote racking system shall have automatic and manual racking control.
- 7.3 The remote racking system shall have an emergency stop located at the main controller of the racking device and at the hand-held touch screen remote control device
- 7.4 Touchscreen control device must show breaker position during the racking cycle.
- 7.5 The remote racking system shall be capable of alarming based on over torque conditions without damaging the circuit breaker.
- 7.6 The remote racking system must be capable of detecting whether the breaker is fully connected or disconnected.



7.7 The remote racking system must be capable of turning back  $\frac{1}{4}$  turn on breakers that require a torque stress relief in the connected position.

7.8 OPERATOR REMOTE

7.8.1 Remote operator panel must show a visual display of the breaker position as it travels between connect and disconnect position.

7.8.2 Remote operator panel must show number of turns required as the breaker travels between connect and disconnect position.

7.8.3 Voltage at the operator remote cannot exceed 24Volts. No AC voltage will be allowed at the operator remote.

7.8.4 Remote operator panel must be touch-screen type and have a color display.

7.8.5 Touchscreen remote shall be customizable without the use of external computers or programming software.

8.0 VENDOR RESPONSIBILITIES

8.1 The bidder must have a minimum of ten (10) years of experience in manufacture and service of remote racking systems.

8.2 The bidder shall submit a minimum of three (3) references for the supply of remote racking systems for switchgear breaker Installations of similar size and service.

9.0 OWNER'S RESPONSIBILITIES

9.1 Owner shall provide escorted access to the various plant switchgear rooms and switchgear locations to allow the bidders to inspect and record the various manufacturers and models/styles of the switchgear in service at the facility.

- 9.2 Owner shall provide access to various breakers for training and demonstration of the racking device(s) operation by the manufacturer's authorized training representative.

## **10.0 WARRANTY**

- 10.1 All equipment shall be guaranteed against defects in material or workmanship for a minimum period of one (1) year from the training date.

## **STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES**
