All prices for purchases by Jefferson Parish of supplies and materials shall be quoted in the unit of measure specified and unless otherwise specified, shall be exclusive of state and local taxes. The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail. Quotations shall be based on F.O.B. Delivered, anywhere within the Parish as designated by the Purchasing Department. JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR. Items bid must meet specifications. JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. 2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. 

Two-year contract for pest control services to cover the furnishing of labor, materials, and equipment necessary for various buildings for the Jefferson Parish East Bank Consolidated Fire Department for the locations listed in Section 10.

Work must be performed on a monthly basis.

SECTION 1 – SITE VISITS:

All bidders can visit all building sites to familiarize themselves with the site and the required work. During each site visit, the bidder will be allowed to ask questions and inspect the site with the owner's representative. SECTION 3 – QUANTITIES/INSPECTION:
