GOODWILL 2015

Goodwill Industries of Southeastern LA, Inc. is currently in its sixty-sixth (66) year of service, (1947-2013) to people with disabilities and other barriers to employment. Although widely known for its retail stores, Goodwill Industries is a 501 C (3) nonprofit organization that helps people with disabilities and other employment barriers help themselves by providing training, education, and employment services to enhance their success in the workplace. In 2012, Goodwill provided education, employment and training services to 5,129 individuals and helped place 1,167 into employment.

In 1947, two Methodist ministers, one in Texas, and one in New Orleans, along with other civic-minded individuals, established Goodwill Industries of Greater New Orleans at a site originally on Chartres Street in the French Quarter. During the ensuing years Goodwill moved physically to Jackson Avenue, Dryades Street, South Jefferson Davis Pkwy and following Hurricane Katrina, moved to a newly renovated facility on Tulane Ave. Our current President is William L. Jessee.

Over this 66-year period Goodwill has moved economically from (2) two employees to approximately 536 with an annual income of more than \$25 million. 30% of the employees have disabilities. Goodwill Commercial Contracting and Facilities Maintenance Services department began in 1985 and currently has 108 employees (95 are janitorial). Goodworks, Inc. was formed in 1997 as Goodwill's federal contracting branch. Goodworks has 72 employees (48 janitorial). 75% of the employees have disabilities that work on many facilities covering duties in Custodial, Grounds Maintenance, Switchboard and Mail Room operations.

Our Programs include: Culinary Arts Training, Computer Literacy Training, C-Tech Broadband Technology Training, START Hospitality Training, Case Management, Job Readiness, Employment Assistance and Training and Supportive Service Opportunities. There are currently seventeen (17) Goodwill Retail stores throughout Greater New Orleans and Baton Rouge. Money, buildings, staff . . . all have demonstrated the growth of Goodwill, but the real growth comes from the number of people served and job placements by Goodwill.




