Regular 28-day mix can be utilized but the street cannot be opened to traffic until the desired strength is achieved.



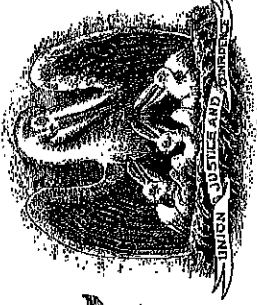

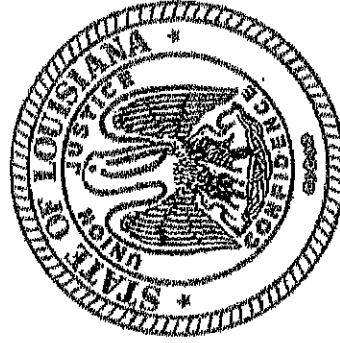
