KNOW ALL MEN BY THESE PRESENTS that (insert full name and address or legal title of Contractor), Sienna Construction, LLC
as Principal, hereinafter called Contractor, and, (insert full name and address or legal title of Surety, SureTec Insurance Company, a corporation duly organized under the laws of the Texas, and authorized to do business in the State of Louisiana, as Surety, hereinafter called Surety, are held and firmly bound unto West Baton Rouge Parish School Board, 3761 Rosedale Road Port Allen, Louisiana 70767 as Obligee, hereinafter called Owner, in the amount of Five Percent of the Amount Bid Dollars (\$ 5%) for the payment whereof Contractor and Surety bind themselves, their heirs, executors, administrators, successors and assigns, jointly and severally, firmly by these presents for the bid of the Contractor for the Project: (Name, address, and Project number, if any) Project Number: C954-PAB - WBR Student Services Building - 780 Pelican Blvd., Port Allen, LA 70767

The Contractor and Surety are bound to the Owner in the amount set forth above, for the payment of which the Contractor and Surety bind themselves, their heirs, executors, administrators, successors and assigns, jointly and severally, as provided herein. The conditions of this Bond are such that if the Owner accepts the bid of the Contractor for the Project within the time specified in the bid documents, or within such time period as may be agreed to by the Owner and Contractor, and the Contractor either (1) enters into a contract with the Owner in accordance with the terms of such bid, and gives such bond or bonds as may be specified in the Bidding or Contract Documents, with a surety admitted in the jurisdiction of Louisiana and otherwise acceptable to the Owner, for the faithful performance of such Contract and for the prompt payment of labor and material furnished in the prosecution thereof; or (2) pays to the Owner the difference, not to exceed the amount of this Bond, between the amount specified in said bid and such larger amount for which the Owner may in good faith contract with another party to perform the work covered by said bid, then this obligation shall be null and void, otherwise to remain in full force and effect. The Surety hereby waives any notice of an agreement between the Owner and Contractor to extend the time in which the Owner may accept the bid. Waiver of notice by the Surety shall not apply to any extension exceeding sixty (60) days in the aggregate beyond the time for acceptance of bids specified in the bid documents, and the Owner and Contractor shall obtain the Surety's consent for an extension beyond sixty (60) days.

This Bond has been furnished to comply with a statutory or other legal requirements of Louisiana La. R.S. 38:2218 C, and any provision in this Bond conflicting with said statutory or legal requirement shall be deemed deleted here from and provisions conforming to such statutory or other legal requirement shall be deemed incorporated herein. When so furnished, the intent is that this Bond shall be construed as a statutory bond and not as a common law bond. 
