Instruction for Completing Bid Form

- 1) For each bid item, the Supplier shall place their bid IN WORDS in the "Description, Quantity, and Unit" column, after the text "Markup per Gallon=". This bid shall be reflective of the Supplier's markup price only, measured from the Lake Charles Opis Rack Average (10:00 a.m.)
- 2) For each bid item, the Supplier shall place their bid IN FIGURES in the "Unit Price" column. This bid shall be reflective of the Supplier's proposed markup price only, measured from the Lake Charles Opis Rack Average (10:00 a.m.)
- 3) For each bid item, the Supplier shall multiply their unit price bid by the total gallons, and place this result in the "Extension" column (in figures).
- 4) The Supplier shall sum all Extensions and place this result in the "Total Proposal" blank.

The above unit prices shall include all labor, materials, overhead, profit, insurance, etc., to cover the furnishing and delivery of the proposed fuel.

Bidder understands that the Owner reserves the right to reject any or all bids and to waive any informalities in the bidding.

The Bidder agrees that this bid shall be good and may not be withdrawn for a period of at least 30 calendar days after the scheduled closing time for receiving bids.
