



Notice of Cancellation form #IL T4 05 edition 05/19 applies to the Automobile Liability policy.

### **Workers' Compensation:**

Waiver of subrogation form #WC 00 03 13 applies to the Workers Compensation policy when there is a written contract between the named insured and the certificate holder that requires such status.

### **Umbrella:**

Notice of Cancellation form #IL T4 05 edition 05/19 applies to the Umbrella policy.

The General Liability, Automobile Liability, and Umbrella policies includes a blanket notice of cancellation to the certificate holder endorsement, providing for 30 days' advance written notice if the policy is canceled by the company, or 10 days' written notice before the policy is canceled for nonpayment of premium. Notice is sent to certificate holders with mailing addresses on file with the agent or the company. The endorsement does not provide for notice of cancellation to the certificate holder if the named insured requests cancellation.
