As indicated within the S.F.-330 submitted, Aucoin & Associates has been providing engineering and land surveying services for general aviation airports in South Louisiana for approximately 32 years.

Our staff maintains a very close working relationship with the LDOTD Office of Aviation staff and strives to stay abreast of FAA funding, planning and design and construction guidelines. One of our staff engineers regularly attends Airport Managers Conferences. Over the past 30 years our firm has provided surveying and/or engineering services at Legros, Eunice, Marksville & DeQuincy airports through contracts with LDOTD and/or directly with the local owner agency.



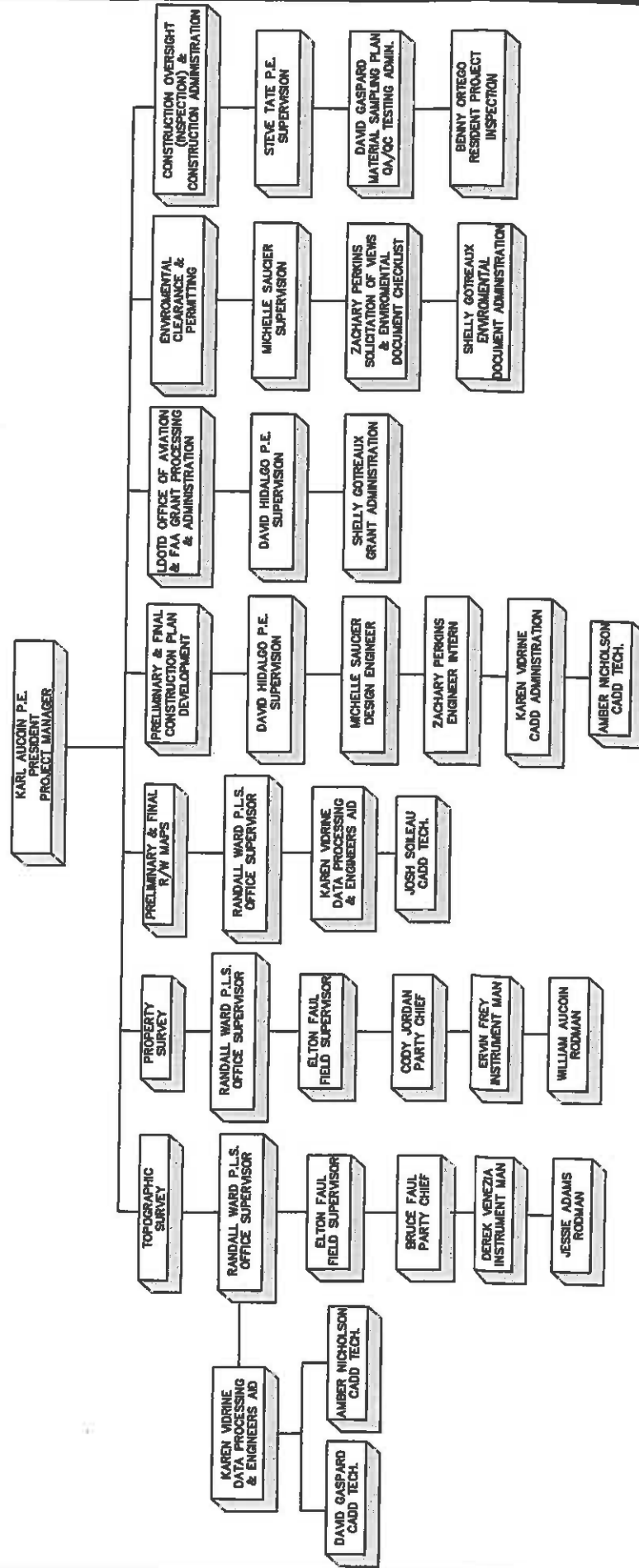

Over the past 30 years our firm has provided surveying and/or engineering services at the Legros, Eunice, Marksville, Bunkie, DeQuincy, Welsh, and Allen Parish airports through contracts with LDOTD and/or directly with the local owner agency.

Land surveying services provided consists of topographic surveys for construction projects and property surveys for preparation of right of way and clear zone maps for acquisition of fee property as well as aviation servitudes.

The process begins by identifying a potential project and consulting with the FAA and LA DOTD Aviation to determine the project justification and eligibility. Once a project becomes eligible and a consultant is selected, a project scope and cost estimates are prepared. Environmental assessment (EA) or Categorical Exclusion (CE) documentation are prepared and submitted to FAA for review and funding. Design, plans, and specifications are prepared, as well as a Construction Safety Plan. Any additional environmental or other permits/approvals are also secured. The next step is to finalize the construction bidding, grant applications (FAA & LA DOTD), and grant acceptance schedules. After the grant is accepted and notice to proceed is issued, the construction of the project begins. The consultant closely monitors the construction of the project and submits monthly progress reports and requests of grant payments. Upon completion of the construction project, a final report and pay request is submitted along with all of the grant closeout documents.

Aucoin & Associates, Inc. is quite knowledgeable with the FAA grant process.
