SPECIAL PROVISIONS

1. SCOPE:

- 1.1 The intent of this solicitation is to obtain competitive bids for the estimated annual requirements for **KITCHEN EQUIPMENT** for the Lafayette Parish School System, in accordance with the terms, conditions and specifications contained herein.
- 1.2 **Required Bid Submittals:** The section titled **BID PROPOSAL FORM** and the following supplemental information must be submitted within the time frames specified below.
 - a. **SPECIAL PROVISIONS**, Paragraph 5.2, requires descriptive literature to be provided with the bid if an item is offered as an equal to the brand name specified.

2. PERIOD OF CONTRACT:

- 2.1 The period of this contract shall be from **date of award through June 30, 2018.**

3. PRICES AND PRICE ADJUSTMENT:

- 3.1 All prices/discounts shall be F.O.B. Destination and shall include all charges that may be imposed in fulfilling the terms of this contract. Prices/discounts shall remain firm for the duration of the contract.

- 3.2 Whenever there is a reduction in price, which is lower than the contract price, offered to similarly situated customers contracting for the same period and under the same terms and conditions, said, reduction must be presented directly to the Purchasing Department of the Lafayette Parish School System.
- 3.3 Prices may not exceed the national advertised and available General Services Administration (GSA) governmental price list.
- 3.4 The Lafayette Parish School System does not intend to award or to maintain any item in any group that is offered at a price equal or above the manufacturer's list price.

4. **QUANTITIES:**

- 4.1 The quantities specified on the Pricing Schedule are estimated only, and are given for the information of bidders and for the purpose of bid evaluation. They do not indicate the actual quantity that will be ordered, since such volume will depend upon requirements that develop during the contract period. The Contractor will be required to fill all orders placed regardless of the original quantities shown.

5. **SPECIFICATIONS AND LITERATURE:**

- 5.1 Manufacturer name and specification or catalog number is design and size for purposes of identification and to denote the standard of quality desired. If there is any deviation in the description/specification, the alternate bid must be clearly indicated. Alternate bid items must be functionally equivalent to the item specified.
- 5.2 Each bidder is required to submit the following information with the BID PROPOSAL FORM:
 - 5.2.a. Catalog cut sheets and/or descriptive literature labeled with the Invitation for Bid number;
 - 5.2.b. Bid item number and bidder's name;
 - 5.2.c. Full illustrations and detailed specifications for each item offered **functionally equivalent** to the brand name specified;
 - 5.2.d. All differences in specifications from brand name must be so marked.
- 5.3 If an "alternate" item is bid, the bidder must indicate the brand and model that meets or exceeds the specified item, along with the unit price for that item.
- 5.4 **Descriptive Literature of the Alternate item must be submitted 10 days prior to the bid closing time and date.**

- 5.5 Descriptive literature is required for the purpose of bid evaluation and award, details of the product(s) the bidder proposes to furnish as to design, materials, method of manufacture, construction, assembly or operation, as appropriate. **Failure to submit the descriptive literature shall be cause for rejection of that item.**

6. **QUOTATION LIMITATION:**

- 6.1 **Bidders shall offer only ONE ITEM AND PRICE for each line item bid.**
- 6.2 A discount price offered for a quantity purchase of the same manufacturer and model would not be considered a limitation; however, only the unit price requested will be considered in the award.

7. **TIME OF PERFORMANCE:**

- 7.1 The awarded bidder(s) shall be required to deliver the respective items within 30 days of receipt of a purchase order from LPSS and at the location specified in accordance with Section 8.1 of this bid.

8. **DELIVERY & INSTALLATION:**

- 8.1 Prior to delivery of equipment, the Vendor must contact Child Nutrition Services at 337-521-7370 to set-up a delivery appointment with the Fixed Asset Coordinator. Deliveries that are not pre-scheduled through the Child Nutrition Services Office will not be accepted and returned at expense of vendor.
- 8.2 Disconnection (if applicable) and/ or removal of existing equipment will be the responsibility of Child Nutrition Services prior to delivery/ installation date.
- 8.3 Deliveries will be made to various locations in Lafayette Parish. Delivery location shall be stated on each purchase order issued.
- 8.4 Warehouse deliveries for the Lafayette Parish Public School System (LPSS), Child Nutrition Warehouse Department, 101 Evans Lane, Lafayette, Louisiana 70506, **will be received between the hours of 8:00 a.m. and 1:00 p.m., Monday through Friday, except on or during School System Holidays.**
- 8.5 Inside delivery direct to schools, centers, or LPSS agencies will include off-loading from the selected carrier and carrying inside the receiving school, center or LPSS agency. Receiving hours will be from 6:30 a.m. through 1:00 p.m., Monday through Friday, except School System Holidays, unless other arrangements have been made with the receiving school, center or LPSS agency.
- 8.6 Vendor must install new equipment at time of delivery.

- 8.7 **Installation** means uncrate, set in place, connection of all utilities, removal of debris, and test of operation.
- 8.8 No equipment purchases are accepted as drop shipped.
- 8.9 Plumbing & electrical are provided by Child Nutrition Services.
- 8.10 Vendor must provide demonstration/ in-service of new equipment by qualified personnel to entire kitchen staff at time of installation or other time scheduled with Child Nutrition Services Fixed Asset Coordinator.

9. **DELIVERY FAILURE:**

- 9.1 Bidders are cautioned to carefully consider the delivery time they indicate in Section 7.1, as they will be required to adhere to that delivery time.
- 9.2 Awarded bidder(s) that do not adhere to the specified delivery time will be penalized 5% of the total price for every 10 days late beyond the specified ARO date. The first day of the ARO is the date that the Purchase Order is faxed or emailed to the awarded bidder(s).

10. **SHIPPING AND MARKING:**

- 10.1 Awarded bidder(s) will be required to mark all shipments with the Lafayette Parish School System **purchase order number** clearly visible on the exterior of each container. A packing slip must be furnished with each **shipment and listing**, in addition to the awarded bidder's **stock number, item description, purchase order number, purchase order item number, quantity ordered, quantity shipped, and quantity back ordered**.
- 10.2 Invoices and all related written materials pertaining to each delivery must show the purchase order number, the purchase order item number, and the item number shown on the contract.

11. **SUBMISSION OF BIDS:**

- 11.1 Bidders must submit the completed bid package using the form provided.
- 11.2 Bidders must show unit price per item and total price for each item bid.
- 11.3 By completing the Bid Signature Form, the bidder acknowledges that the invitation was read, understood, and is in agreement to be bound by its terms and conditions.

- 12.2 If awarded, the Lafayette Parish School System will award the contract to the lowest responsive and responsible bidder. LPSS reserves the right to award the contract in the aggregate or to make a split award to more than one bidder, whichever is in the best interest of the public.

13. **PURCHASE ORDER:**

- 13.1 Purchase order(s) for the items listed in this solicitation will be issued as required throughout the period of this contract and will become an integral part of the resulting contract. The purchase order indicates that sufficient funds have been obligated.
- 13.2 The purchase order does not supersede any provision of the resulting contract. Performance time and dates are determined solely by the contract and any modification thereto.
- 13.3 Shipment is not to begin until receipt of the purchase order or other notification by the Purchasing Agent to proceed.

14. **ORDER OF PRECEDENCE:**

- 14.1 In the event of conflict, the Special Provisions of this contract shall take precedence over the General Conditions and Instructions to Bidders, included herein.

- 24.1 LPSS has the right to cancel any contract for cause including, but not limited to, the following: (1) failure to deliver within the time specified; (2) failure of the product or service to meet specifications or to be delivered in good condition; (3) fraud, collusion, conspiracy or other unlawful means of obtaining any contract with LPSS; (4) misrepresentation by the selected bidder(s); (5) conflict of contract provisions with constitutional or statutory provisions of state or federal law; and/or (6) any other breach of contract.

- 24.2 LPSS reserves the right to cancel any contract within thirty (30) days written notice.

25. **APPLICABLE LAW:**

- 25.1 All contracts shall be construed in accordance with and governed by the laws of the State of Louisiana.
- 25.2 In the event of a dispute between the parties, the 15th Judicial District Court for the Parish of Lafayette shall serve as the sole and exclusive jurisdiction and venue to resolve said dispute.

- 1. For each of the Traulsen pieces how many tray slides sets do you want? It is usually easier to say XX per section. For example 10 sets per section. The pairs run about 150 each, so the quantity can result in a wide price shift. This is for items 3, 4, 5, 6, and 7.**
