Section 8.0 - Hours of Work:

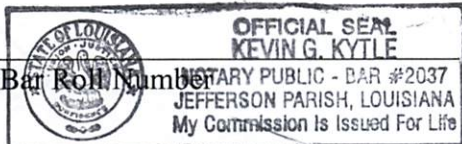
